BACKGROUND INFORMATION: There is a seat expiring December 31st on the Planning Commission. The sitting board member, Kit McKeon, did reapply. Seven members appointed pursuant to City Charter from among residents of the city. An eighth member of the commission shall be appointed by the Sarasota County School Board, in accordance with F.S. 163.3174(1), and need not be a resident of the city. The school board appointee shall be a non-voting member and may participate in comprehensive plan amendments and rezoning agenda items that would, if approved, increase residential density on the property that is the subject of the application.
