Request to purchase one (1) refuse truck

Background:

We are seeking approval of the Mayor and City Council to utilize a cooperative purchasing agreement to purchase one (1) refuse truck off of the Florida Sheriff's Association's bid (# 13-11-0904).

This truck is a 2015 Mack "front loading" refuse truck with a 40 cubic yard "EZ Pak" container set-up. This truck is needed, additional to the ones already in service and will replace older Units # 465 & 466. These older units have be taken out of service, parted out and will be sent to auction. Please see the attached report from fleet maintenance stating replacement justification. The final total price is \$263,587.00 and the Public Works-Recycling Division has \$265,000,000 budgeted for this truck. This purchase was detailed in the 2013-2014 Fiscal Year Adopted Budget.

This request is made in concurrence with John Veneziano, Public Works Director and Bob Moroni, Solid Waste/Recycling Superintendent.

To whom it may concern,

At the request of the Solid Waste Department, we performed an overall evaluation to Units #465 and 466. The vehicles are 2007 Auto Car EZ pack Front Loader Rubbish Trucks. After performing these evaluations, we feel that these vehicles can no longer meet the needs of the Solid Waste Department . The bodies are deteriorating and rusting out and the vehicles are showing signs of excess wear. Some of the hydraulic components have been removed and put into stock for use on other EZ Pack vehicles. Auto Car repair and replacement parts costs for the chassis are much higher than those of the other manufactures in S/W fleet, therefore the maintenance and repairs costs to these vehicles will be much higher. Needed and projected repairs to these vehicles in the near future and the condition of these trucks aid us to recommend that the vehicles be disposed of at this time.
