V. PRESENTATION

Jon Thaxton, Gulf Coast Community Foundation, Matt Sauer, Charles and Margery Barancik Foundation, and Kirsten Russell, Community Foundation of Sarasota County: Sarasota Housing Action Plan (20 min.) (Requested by Council Member Frank)

Kirsten Russell, Community Foundation of Sarasota County, and Matt Sauer, Charles and Margery Barancik Foundation, presented a study on affordable housing including the topic being important for the area, working with consultant, foundation partnerships, demographics, impact on business community, housing costs, housing market, Area Median Income (AMI), commuting demand, shortage of attainable housing, options for assistance, utilizing a portion of county tax for housing trust fund to incentivize development of affordable housing, reducing fees for projects, accessory dwelling units (ADU), zoning options, dedication of land for affordable housing, partnerships with community organizations, and input from workforce.

Jon Thaxton, Gulf Coast Community Foundation, presented solutions dependant on partnerships, identifying opportunities within the organization's control, workforce needed to have lifestyle services, use of public land, consideration of affordable housing in all policy decisions, report being specific to Sarasota County, and the need to utilize multiple options.

Discussion took place regarding consideration of affordable housing, affordable housing trust fund option, potential use of public land, non profit partnerships, Habitat for Humanity project, and support from employers.

Recess was taken from 10:15 a.m. to 10:30 a.m.

VI. PUBLIC HEARINGS

A. APPEAL HEARING SCHEDULED FOR 10:30 A.M.

Consider and Act on Appeal of Planning Commission's Approval of Variance Petition No. 25-22VZ for Relief from the Venice Historical Precedent Architectural Requirement in the Airport Avenue Zoning District for the Property Located at 240 Base Avenue East, Owned by Walt Kitonis, Technology Development Properties LLC (Quasi-Judicial)

Mayor Pachota read the item and opened the public hearing.

City Attorney Fernandez questioned Council Members concerning ex-parte communications and conflicts of interest. Mayor Pachota disclosed ownership of property on the same block and stated he can remain fair and

unbiased based on the record presented today.

Mr. Engelke disclosed a site visit, viewing of the Planning Commission hearing, and a discussion with City Attorney Fernandez.

Mr. Smith disclosed viewing the Planning Commission meeting.

Mr. Howard, Vice Mayor Boldt and Mayor Pachota disclosed attendance or viewing of the Planning Commission hearing, and a site visit.

Mrs. Frank and Mr. Weed disclosed a site visit.

Written communications were provided in advance.

City Attorney Fernandez provided introductory comments on the appeal and led Council through consideration of the appellants standing for appeal.

Peter Zeh, being duly sworn, commented on proximity of the appellants to the applicant's property.

Attorney Jeffery Boone, being duly sworn, stated case law provides for his client's right to cross-examination and appellants who are not present do not allow for that and objected to any appellants who are not present.

Peter Zeh commented he represented the group.

City Attorney Fernandez indicated Council can address the appellant who is present to determine standing.

Peter Zeh indicated his distance from the parcel, the property borders the mixed use development corridor and impacts him based on architectural, visual, traffic, and safety standpoint.

Attorney Boone questioned Mr. Zeh regarding the location of his residence and indicated Mr. Zeh does not have standing to be an appellant, reviewed the standard for an affected party in the code, architectural design, and noted that uses are not part of this variance only design, and stated Mr. Zeh is not impacted by the application.

Mr. Zeh clarified his reasons for being an affected party and appellant.

A motion was made by Mr. Smith, seconded by Mrs. Frank, to approve Peter Zeh's standing to appeal.

Discussion took place regarding who would have standing for appeal.

The motion carried by the following electronic vote:

Attorney Jeffery Boone, filed a Motion in Liminie to limit testimony to what is relevant to the variance.

City Attorney Fernandez recommended not acting on the Motion in Liminie and stated the mayor can determine whether testimony is relevant or not.

The motion was acknowledged; no action was taken.

Mayor Pachota asked Mr. Zeh, appellant, to keep his presentation specific to the appeal that was filed.

Attorney Boone requested additional rebuttal time of 10 minutes, for a total of 20 minutes. No action was taken.

Senior Planner Tremblay, being duly sworn, presented the petition information, aerial view, project description, intent for industrial type building, site photos, future land use map, zoning map, conceptual site plan, conceptual elevations, relevant code standard, requirement of Venice Historic Precedent (VHP) style, decision criteria, clarifying information for appeal, notice of LDR change in 2022, property ownership at time of notice, potential uses allowed, and adaptive reuse definition.

Attorney Annie Boone, being duly sworn, questioned Senior Planner Tremblay on transfer of property in 2020 and 2022. There were no questions from the appellant.

Senior Planner Tremblay answered Council question on the property transfer and public notice.

Attorney Jeffery Boone indicated for the record he was representing the applicant, but would also be providing testimony in this matter.

Attorneys Jeffery and Annie Boone, Agents, and Walt Kitonis, Applicant, being duly sworn, presented on the location, the Planning Commission Decision, current condition of property, intention to redevelop, under prior Land Development Regulations (LDRs) property was not in Venice Historic Precedent (VHP) district, old zoning and non conforming uses, background, intent to improve property, proposed potential uses, potential partnerships, building transition options, attempted communications with appellants, demolishing of existing structures, build one large facility, improvement in appearance, aerial photo, renderings, space for community, metal building not within VHP style, surrounding properties not

within VHP, metal buildings are historic in area, reason for variance request, compliance with LDR, compatibility, variance criteria, hardship due to change in LDR architectural standards, site being unique, uses are within current zoning, the history in the area, still have site and development review, and case history.

Attorney Boone responded to Mr. Zeh's request he provide proof of the alleged flaw in the case law presented by the Appellant.

Recess was taken from 11:56 a.m. to 2 p.m.

Peter Zeh, Apellant, provided a presentation to include the reason for the appeal, review of Comprehensive Plan, the Land Development Code, and the Variance Application, VHP Style Architecture, Uses, Land Use Compatibility, Variance criteria, and decision criteria.

Lueanne Wood, 550 West Flamingo Drive, spoke in favor of the application.

Rick McNamara, 316 Parkdale Drive, spoke in favor of the application.

Ryan Baldauff, 251 Airport Ave East, expressed concerns regarding uses.

Recess was taken from 2:37 p.m. to 2:42 p.m.

Senior Planner Tremblay indicated the requirement of the decision criteria to grant a variance was to make an affirmative finding on each of the criteria.

There was no appellant summary.

Agent for Applicant, Attorney Boone, commented on uses not being at issue, site and development plan are a separate matter, the variance request being for architectural design standards only, testimony and evidence presented today, zoning code change, uses not being at issue, noise, permitted uses, case law, meeting criteria, and evidence in the record.

Mayor Pachota closed the public hearing.

A motion was made by Vice Mayor Boldt, seconded by Mr. Howard, that based on the evidence in the record, Variance Petition No. 25-22VZ be approved and adopted.

Discussion took place regarding variances, properties in disrepair, exceptions, neighboring properties, land development regulations, improving properties, the neighborhood, and land use strategies.
