
#### The Twig 5K Route (Legacy Park) Appendix A


Start at Legacy Park/ Playground trail heading Northwest on the paved path towards Legacy Trail. Cross Seaboard Avenue at cross walk turning right onto Legacy Trail. Head North on Legacy Trail turning around at Colonia Road before trail median. Heading South on Legacy Trail enter Nokomis Park path (coquina shell path). Follow park path around to exit onto Legacy Trail heading South crossing at Seaboard Avenue. Finish at Legacy Park same destination as start.




### The Twig Fun Run Route (Legacy Park) Appendix E


