Request for Affected Person Status

I will be adversely affected by the approval of the applicant's site plan petition to a greater degree than other residents of the city of Venice at large in the following respects:

- I live in the Venetian Golf and River Club community. I drive through the entrance to the VGRC frequently, either entering or leaving the community. If the current site plan is approved and the project is built as planned, I will be required to drive through and attempt to negotiate what will be an unsafe intersection at Laurel Road and Veneto Boulevard in front of the VGRC entrance.
- My home is located approximately 1,100 feet from the project's northern boundary. The applicant's stormwater management plan is based upon outdated data and incorrect calculations. The stormwater permit issued for the project is based upon outdated and understated rainfall data. If the project is built as planned, there will be an increased risk of flooding in the area.
- Because of the proximity of my home to the proposed incompatible commercial center, I will experience the adverse consequences of the project, including increased traffic, congestion, noise, and light pollution. The nighttime view from my lanai will be affected by the parking lot lights which will be on all night long.
