SUBJECT / TOPIC: Sale of EMS Unit to SRQ Airport Authority

BACKGROUND INFORMATION:

The Fleet Department is preparing to sell Unit 16-188 (2016 International Rescue Van). This unit no longer provides use for the city due to lifecycle and type of unit. The unit was purchased in used condition in November of 2022 at a cost of \$50,075.00. With that, the unit required approximately an additional \$5,000 in repairs immediately after purchase to keep the unit in workable condition. The need for this unit was based on two items: (1) coverage for the city's life-saving EMS operations (2) original EMS unit being out of service for over a year waiting for repairs and parts due to an accident. The original unit has since been repaired and is back online and there is no need to keep the used unit within the fleet due to age and style.

The Sarasota Airport Authority (SAA) is starting up an EMS service for the SRQ Airport and has shown interest in our unit that will be sold at auction. Members from the leadership team at SAA have come to Venice to view the unit in person and have decided that it meets the needs for the airfield and have requested to purchase this unit direct from the city to use at the SRQ airport.

The proposed sale price given to SAA for this unit is \$55,000. With that, the SAA has provided a Letter of Intent to purchase Unit 16-188. After reviewing comps within the market for this type of unit, the Fleet Department agrees that this is a fair price based on age and condition. This is also very comparable to the price the city would receive for this unit at auction.

As noted in Ordinance No. 2020-12 Sec. 2-226, "a listing of all salable items, not including scrapped items, for either public auction or by sealed bid shall be approved by the finance director, or designee, and such sales will be to the highest responsible bidder." However, Section 274.05, Florida Statutes, allows for the city to "offer surplus property to other governmental units in the county...for sale or donation." Based on this provision in state law, the city has been able to assist other governmental agencies in the area with the direct sale/donation of a surplus unit with council support and approval.

The Fleet Department is requesting approval from Council for the direct sale of this unit to the Sarasota Airport Authority to assist them with starting EMS services at their facility. The unit will

be sold AS IS WHERE IS, with no obligation from the city after the sale is complete. All information will be kept showing the vehicle was sold at fair market value.
