Commissioner Robinson and Council Member Daniels,

Chief Tobias advised that you were inquiring about specifics regarding our special detail program as it relates to special events across the county. Please peruse what I have below and if you have any further questions or concerns feel free to contact me personally.

Public Service Aide (civilian) \$29/hr.

Deputy \$35/hr.

Sergeant \$40/hr.

Lieutenant \$44/hr.


Marked Vehicle (required for traffic related events) \$10.00/hr.

- 3 hour minimum An employee can work less than 3 hours but must be paid for 3 hours
- 5 9 deputies require the hiring of a sergeant
- 10 14 deputies require the hiring of a sergeant and lieutenant

As to the determination of public safety requirements for a particular event, that can vary depending on the event. Typically an event organizer will either contact the sheriff's office directly or go through County Planning to obtain a permit. Once the sheriff's office is notified, we will review all aspects of the event. There really is no set formula on how many deputies/officers to staff an event. We look at a number of factors that include; type of event, venue, expected attendance, environmental factors,

alcohol permitted, prior similar events, etc. We then use the training and experience of our staff to outline a staffing plan to effectively handle all probable issues that may occur.

Good Afternoon Commissioners and Vice Mayor

We are advised of the events along with other County agencies through the Temporary Use Permit (TUP) procedure.

Currently Sarasota County Fire Department charges the following rates for special event coverage under Resolution 2003-318:

Fire Engine: \$45 per hour Ladder Truck: \$45 per hour Brush Truck: \$35 per hour

Special Operations Squad: \$45 per hour Command Vehicle: \$8.50 per hour

Ambulance: \$21 per hour Fire Boat: \$27 per hour

Personnel costs: Actual wage of personnel

We determine the coverage needed on factors including: number of participants, location and geography of event, type of event, weather conditions, time of day, number of days, likelihood of injuries and other factors such as alcohol being served.

I am not familiar with the Sheriff's special event operations, so I forwarded your email to Colonel Burns and asked him to reply to you.

Good Morning,

Within Sarasota County, there is a Temporary Use Permit Process (application is attached) where large events, those with large tents, the use of port-o-lets etc.. must be reviewed by multiple departments including the Sheriff's Office, Fire, Zoning etc... If it is determined that Paramedics or Sheriff's Deputies are needed during an event, charges would be based on the quantity and the type of coverage needed. Unless it is a County sponsored event, the fees associated with these services would be paid by the organization or individual requesting the event.

The various municipalities within the County have their separate rules and protocols that must be followed.
