CALL TO ORDER

Mayor Pachota called the meeting to order at 9:00 a.m.

Ruth Cordner, 246 Montelluna Drive, spoke on property owner rights, PUD amendments, and unified control.

Paula Steinert, 119 Ventosa Place, expressed concerns about traffic on Knights Trail, and recommended using impact fees for the widening of Knights Trail, instead of Laurel Road.

Discussion took place regarding the needs of Knights Trail, Laurel Road, impact fees, and concerns about flooding, wetlands, and climate change.

City Manager Lavallee addressed concerns, noting this approval is a request from the County as a courtesy, they do not need City approval to use impact fees, and the City initiated the request to move Laurel Road up on the priorities. He noted impact fees can only be used to expand capacity and could not be used for a traffic light.

Discussion took place regarding the increased need for traffic mitigation on Laurel Road, Knights Trail, and Jacaranda, financial impacts and appropriations, positive infrastructure improvements, time to get projects done, and inability to move funding.

A motion was made by Vice Mayor Boldt, seconded by Ms. Moore, to approve Item No. 24-0274. The motion carried by voice vote, 6-1, with Ms. Farrell dissenting.

B. PRESENTATIONS WITH ACTION

24-0275 Planning and Zoning Director Roger Clark: Special CounselRecommendations for PUD Amendments

Planning and Zoning Director Clark provided a history of the topic.

Alison Yurko, Special Counsel, provided a presentation to include an overview of the recommendations, the need for amendment options, reviewed options, other cities' ordinances, the City of Venice ordinance, unified control, and decision criteria.

Discussion continued regarding definitions of substantial, insubstantial, major, minor, and consent definitions, new PUDs, unified control, determining evidence, enforcing private covenants, HOAs individual level, acreage basis versus parcel basis, net developable acreage that has been granted land use entitlements through the PUD, ownership, certificate of occupancy, building permit, unified control at outset before any change, developers having a pathway to ask for an amendment, retaining property rights, time limits, and the HB1C special act (law) pertaining to this area, which prevents municipalities from legislating anything more restrictive or burdensome until October 1, 2026.

City Attorney Fernandez noted the discussion, refined options, the special act, and ordinance language to come back to Council.

Discussion continued regarding existing PUDs, golf courses, concerns about perception of bait and switch, protecting lot buyers, not just building permits, not addressing specific PUDs, not making the process too complicated, and individual homeowners versus a homeowners association when establishing unified control.

Recess was taken from 11:17 a.m. until 11:22 a.m.

Olen Thomas, 248 Acerno Drive, spoke on the presentation, and was optimistic that there will be something that defines unified control appropriately.

Jeffrey Boone, 1001 Avenida Del Circo, spoke on unified control, pleased with recommendations by the consultant, veto power not lawful, has to be a path, does not agree with current city code consent being 100%, and Neal Properties wants a fair PUD amendment process.

A motion was made by Mayor Pachota, seconded by Vice Mayor Boldt, to direct staff to work with special counsel to refine the document presented today with today's feedback and return with a more complete document.

Discussion took place regarding the last buyer being protected as much as the first buyer, lot buyers being protected as much as those with building permits, recommendation that property identified in a master plan as to be developed not having to face the same guidelines as much as changing from one type to another, and clarifying minor and major changes, with major changes going back through the process.
