



## Mast, DeSantis Urge South Florida Water Management District To Delay Decision On Extension Of EAA Southern Storage Reservoir Land Lease

**Stuart, FL** – U.S. Congressman Brian Mast (FL-18) and Governor-Elect Ron DeSantis tonight issued the following statement after learning that the South Florida Water Management District plans to hold a vote tomorrow, November 8, 2018, on extending the land lease with New Hope Sugar Company, a subsidiary of Florida Crystals, for land authorized to be used for the EAA Southern Storage Reservoir:

"Given that the current lease does not expire until March and because we did not receive enough advance notice on this proposed vote to ensure that this extension would not delay construction of the EAA Southern Storage Reservoir, we urge the South Florida Water Management District to delay their planned vote tomorrow. The EAA Southern Storage Reservoir is a critical component of Everglades Restoration and our joint efforts to prevent harmful algal blooms. We will not support any lease extension that could delay the construction of the reservoir in direct contradiction of the intention of both the United States Congress and Florida Legislature."

## Water district drops post-election bomb

**OUR POSITION:** The South Florida Water Management District may have sabotaged Ron DeSantis' promise to expedite a fix for Lake Okeechobee runoff.

kullduggery. That's the best word we can think of for the underhanded actions of the South Florida Water Management District's last-minute lease agreement with Big Sugar.

The water district, whose entire board was appointed by Gov. Rick Scott, approved a lease for land scheduled to be used as a south reservoir for Lake Okeechobee's algaeinfested water runoff. The lease puts land, targeted to provide relief to Southwest

Floridians plagued by bluegreen-algae this past summer, under the control of New Hope Sugar Co., a subsidiary of Florida Crystals, until 2027. The lease, at a cost of about \$1 million a year, provides acreage for farming, according to a story by Tyler Treadway, of Treasure Coast Newspapers.

To be transparent about our angst, there is a clause that might allow Hope Sugar to sell or lease enough land for the reservoir, with four months notice. The whole process, however, is nothing but a headache to the next governor, likely Ron DeSantis who favors the reservoir and made it a campaign promise.

What makes the board's action even more stinging. is the fact the approval of

the lease might actually be illegal. It seems, according to Treadway, the board added the topic to its agenda at 9 p.m. the night before it met. Giving less than 24 hours notice would undermine Florida's Sunshine laws.

U.S. Rep. Brian Mast, R-Palm City, had told board members he and DeSantis wanted to be briefed on the proposal before it was approved to assure it presented no "additional hurdles" to the reservoir, according to the Treadway article. The article went on to say after the vote, the congressman said it was "frustrating to be sideways with them on this, but it's not surprising."

Mast fears the federal government might hesitate to

pony up its half of the \$1.8 billion reservoir cost because of the lease.

The Everglades Foundation has asked Gov. Scott to demand the resignations of the board members. Its executive director wrote: "I must conclude your administration is complicit in this illegal maneuver that benefits a single sugar company over the interests of the people of Florida ..."

According to Treadway. Kimberly Mitchell, executive director of the Everglades Trust, is threatening a suit to stop the lease.

Board members who voted for the lease say they have done nothing wrong. The land must be used for farming, according to a state law. And,

they argue that acting on the lease quickly will allow the district to stock rock and fill dirt at the site for work that must be done in the dry season.

We agree with one critic who called the action a "post-election double-cross."

It would be hard to believe Gov. Scott knew nothing of the pending lease deal. It surely raises the question of whether or not his hand-picked board followed through on policies he favored in his eight years as governor. And that raises fear in our book of how Scott will represent Florida's best interests in Congress, despite his campaign face of a person who put our environment over special interests.
