- Managed complex air operations and \$1.1 billion in airfield construction, coordinating with Daniel K. Inouye International Airport while collaborating with all stakeholders to ensure smooth coordination, supporting thousands of DoD flight operations, and hundreds of high-profile missions and events.
- Collaborated with city, state and elected officials to create a \$200 million project, enhancing emergency evacuation for Honolulu County in response to hurricanes, wildfires and other natural disasters.
