## **RESOLUTION NO. 2023-37**

A RESOLUTION OF THE CITY OF VENICE, FLORIDA, AMENDING RESOLUTION NO. 2023-33 TO REVISE THE DESIGNATED POLLING PLACES FOR THE GENERAL MUNICIPAL ELECTION TO BE HELD ON TUESDAY, NOVEMBER 7, 2023; AND PROVIDING AN EFFECTIVE DATE

**WHEREAS,** the Sarasota County Supervisor of Elections is responsible for administering all federal, state, county, municipal and special district elections in Sarasota County, including the selection of polling places; and

**WHEREAS,** Section 22-3 of the City Code of Ordinances requires the City Council to designate the polling places for municipal elections by ordinance or resolution; and

**WHEREAS,** the City of Venice adopted Resolution No. 2023-33 on August 11, 2023 to designate polling places for the general municipal election to be held on November 7, 2023; and

WHEREAS, the City was subsequently notified by the Sarasota County Supervisor of Elections that areas annexed into the City of Venice identified as Precincts 307.3 and 431.3 will be assigned to the Church of the Nazarene location for the November 7, 2023 municipal election; and

**WHEREAS,** the City Council desires to amend Resolution No. 2023-33 to incorporate the polling places for the additional precincts.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF VENICE, FLORIDA:

**SECTION 1.** The above Whereas clauses are ratified and confirmed as true and correct.

**SECTION 2.** Section 4 of Resolution No. 2023-33 is hereby superseded and replaced by the following:
