SUBJECT / TOPIC: Automated Speed Enforcement in School Zones

BACKGROUND INFORMATION:

- House Bill (HB) 657 was approved by the Florida Legislature and signed by Governor Ron DeSantis on May 31st, 2023. Under this law, the use of cameras is authorized to enforce speeding violations in school zones throughout the school day.
- A study conducted in November 2024 identified the zones around Venice High School and Epiphany Cathedral School as suitable candidates for automated speed enforcement.
