## **ORDINANCE NO. 2024-20**

AN ORDINANCE AMENDING THE OFFICIAL ZONING ATLAS OF THE CITY OF VENICE, FLORIDA, PURSUANT TO ZONING MAP AMENDMENT PETITION NO. 24-03RZ, TO CHANGE THE ZONING DESIGNATION FOR THE PROPERTY LOCATED AT 2695 CURRY LANE (5.0 ± ACRES), FROM SARASOTA COUNTY OPEN USE ESTATE 1 (OUE-1) TO CITY OF VENICE OFFICE, PROFESSIONAL AND INSTITUTIONAL (OPI); PROVIDING FOR REPEAL OF ALL ORDINANCES IN CONFLICT HEREWITH; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE

WHEREAS, Zoning Map Amendment Petition No. 24-93RZ ("Petition") has been filed by Abdelrahman Ayyad, to change the official City of Venice Zoning Map designation for the property located at 2695 Curry Lane from Sarasota County Open Use Estate 1 (OUE-1) to City of Venice Office, Professional and Institutional (OPI); and

WHEREAS the subject property is located within the corporate limits of the City of Venice; and

**WHEREAS,** the City of Venice Planning Commission has been designated as the local planning agency in accordance with F.S. 163.3174;

**WHEREAS,** the Planning Commission held a noticed public hearing on July 2, 2024, regarding the Petition and, based upon the evidence and testimony received at the public hearing, voted to recommend approval of the Petition; and

**WHEREAS,** the Venice City Council has received and considered the report of the Planning Commission concerning the Petition; and

**WHEREAS,** City Council held a duly noticed public hearing on the Petition in accordance with the requirements of the City's Code of Ordinances, and has considered the evidence and testimony received at said public hearing.

## NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF VENICE, FLORIDA:

- **SECTION 1.** The Whereas clauses above are ratified and confirmed as true and correct.
- **SECTION 2.** The City Council hereby makes the following findings of fact:
- A. The Council has received and considered the report of the Planning Commission recommending approval of the Petition.
- B. The Council held, after due public notice, a public hearing on the Petition and considered the evidence and testimony received at said public hearing.

C. The proposed rezoning of the property described herein is in accordance with and meets the requirements of the Land Development Code and is consistent with the City of Venice Comprehensive Plan.


**SECTION 3.** The Official Zoning Map is hereby amended, by changing the zoning classification for the following described property located at 2695 Curry Lane from Sarasota County Open Use Estate 1 (OUE-1) to City of Venice Office, Professional and Institutional (OPI), subject to the following stipulation:

1. A site and development plan shall not be approved until it can be demonstrated by the applicant that the Southwest Florida Water Management District permit issues for Curry Lane have been resolved, along with any other issues identified as causing flooding on Curry Lane.

The 5.0  $\pm$  acre property designated as Parcel Identification No. 0387-12-0003 is depicted on the location map shown below, and further described as follows:

## **2695 CURRY LANE**

Lot 3, WOODLAND ACRES, according to the map or plat thereof, as recorded in Plat Book 20, Page 3, of the Public Records of Sarasota County, Florida.



Any discrepancy between the legal description and the map shall resolve in favor of the map.

**SECTION 4.** All Ordinances or parts of Ordinances in conflict herewith shall be and the same are hereby repealed.

**SECTION 5.** If any part, section, subsection, or other portion of this ordinance or any application thereof to any person or circumstance is declared void, unconstitutional, or invalid for any reason, such part, section, subsection, or other portion, or the prescribed application thereof, shall be severable, and the remaining provisions of this ordinance, and all applications thereof not having been declared void, unconstitutional, or invalid, shall remain in full force and effect.

**SECTION 6**. **Effective date.** This Ordinance shall take effect immediately upon its approval and adoption as provided by law.
