Planning Manager Amy Nelson provided a presentation on the Comprehensive plan including the project description, evaluation and appraisal process, accessibility issues in the document, new legislation, elements, land use, transportation and mobility, open space, housing, infrastructure, public school facilities, private property rights, neighborhoods, appendix, and conclusion.

Planning and Zoning Director Roger Clark answered Council question regarding Joint Planning Agreement (JPA) language, the importance of annexation, mixed use section removed and is now in the code, first fully implemented Comprehensive Plan, and the City Code being in compliance with the Comprehensive Plan.

Discussion took place on capacity for potable water and wastewater for potential growth.

Planning and Zoning Director Clark responded to Council questions regarding the Comprehensive Plan being a visioning document which gives options, the JPA expiration, the roadway section, widening, floor area ratio, impervious surface, the airport terminal building, and fixed base operator.

Airport Director Mark Cervasio addressed the terms airport terminal building versus administration building being from the Florida Department of Transportation (FDOT) and the Federal Aviation Association (FAA), in relation to grant funding.

Planning and Zoning Director Clark answered Council questions regarding Planned Unit Developments (PUDs) and the Land Development Regulations (LDRs), consistency, and timeframe for submittal to the state.

Discussion took place on the timeframe of the Comprehensive Plan.
