Assistant City Manager Clinch and Planning and Zoning Director Clark presented on the history of the permitting process, code modified to alleviate congestion on sidewalks and to implement a more administratively efficient process, two workshops held, collected data from other cities, proposing an annual approval, increased cleanliness standards, enforcement provisions through code enforcement, complexity of larger fee bases, small number of participating businesses, and answered Council questions on fairness for business size, staff discretion, clarifying language, one time permit unless changes take place, current permit holders, enforcement logistics, option of space rental fee, monitoring staff cost compared to revenue, and one time fee compared to an annual fee.

City Attorney Fernandez and City Manager Lavallee clarified current ordinance language, the cost to be set by City Manager, and ability to proceed with clarification of details reviewed and final approved given at second reading.

City Attorney Kelly Fernandez, Planning and Zoning Director Roger Clark, and Assistant City Manager James Clinch: Land Development Regulations (LDR) Citizen Petition Update

City Attorney Fernandez reviewed the outside counsel memorandum.

Assistant City Manager Clinch and Planning and Zoning Director Clark presented the process of creation of the new LDRs, the citizens referendum details, past meetings with Venice Unites, focus on the six items of concern, building height history, industry measuring standards, affects on roof lines, negative affect on property rights, causing non-conforming properties, complications with rezoning, option to add note to allow height exception to property north of Tampa Avenue only, Planned Unit Development (PUD) neighborhood description, commercial use size scale, policy 8.2 is disbursed throughout new LDRs, Unified Control percentages, the merging of boards and creation of the Historic and Architectural Preservation Board (HAPB), creation of historic districts by application, importance of maintaining property rights, protected species guidelines, and Planning Department monitoring and requesting revisions where needed.

Assistant City Manger Clinch addressed the process the petitioners selected, Council's options including continuing communications with the petitioners and public or to take no action at this time.

Discussion took place in regards to rejecting petition filing, having a special session, taking no action today, jeopardizing compliance with State of Florida, possible amendment to City Charter to address the petition process, staff recommendation to not accept filing to prevent liability to City's operations, and six month window for signatures.

Discussion took place regarding ability to define reasons, vagueness of listed reasons, abuse of privilege of virtual attendance, advanced notice of

absence, members being accountable to citizens, verbiage, accepted standard to attend virtually, and right to revoke if being abused.

There was consensus to have the City Attorney revise the Council Attendance Resolution to state that a Council Member who notifies the City Clerk in advance with a request to attend a Council meeting virtually will be deemed excused by the Council, and to add language that the right to attend virtually could be revoked if necessary.

Public Works Director Simpson and Assistant Public Works Director Castle presented public works update, debris removal details, sport parks updates, and staffing morale. City Council stated appreciation for public works staff.
