- 1. Pursuant to Section 86-500 of the Code of the City of Venice, the undersigned Code Inspector hereby gives notice of an uncorrected violation of the Code of the City of Venice, as more particularly described herein, and hereby requests a PUBLIC HEARING before the **Special Magistrate**. - 2. The will **Special Magistrate** will hear this matter on **September 27th, 2023**, or as soon thereafter as this case may be heard, in the Council Chambers 1st Floor, City Hall, 401 W. Venice Avenue, Venice, Florida, at 10:00 am.
- 3. If you have cleared the violations by the time stated in the Notice of Violation and have received written notification from the Director of the Department or his/her authorized designee that all the violations have been cleared, the hearing may be canceled and you will not be required to appear.
- 4. IT IS YOUR RESPONSIBILITY TO CONTACT THE COMMUNITY RESOURCE DIVISION TO ARRANGE FOR A REINSPECTION OF THE PROPERTY IN ORDER TO VERIFY THAT THE VIOLATIONS HAVE BEEN CORRECTED AND THAT THE PROPERTY HAS BEEN BROUGHT INTO COMPLIANCE WITH THE APPLICABLE SECTIONS OF THE CITY OF VENICE CODE.
