Ms. Dowling & Councilman Daniels. With the information you both provide , it appears that an underground option is not immediately feasible given both the time constraints for the "hardening" project and the time within which the City will need to evaluate our request for the underground option. Accordingly, I believe the consensus is to immediately convert to concrete poles and for us start a process with the City to include underground in a future capital budget. This is in accordance with the comments and information that each of you provided at our meeting. Anyone who may disagree with the above is certainly invited to weigh in on this.

Please allow this to confirm that the concrete pole conversion will eliminate the extra, additional pole recently installed and that the revisions can be done in the current project. Also, we expressed a preference for the square pole type if possible.

Councilman, please include this on the next July meeting agenda with the intent that someone from Golden Strand will address the Mayor and Council to plead our case.

Ms. Dowling, can you forward me a electronic copy of the info you provided at the meeting ?
