Mr. Cautero spoke regarding the county's home rule tax increment district, community reinvestment area (CRA), suggested staff or the economic development advisory board (EDAB) explore options for certain projects, and commented on protocol to request time on the board of county commissioner's meeting agenda.

Discussion followed regarding the county's initiative, CRA, and city's revenue.

<u>18-3401</u> Discuss Open Burning of Land Clearing Debris from Development and Direct the City Attorney to Determine Whether Venice Can Influence the Management of this Activity Within City Limits (Cautero)

> A motion was made by Council Member Cautero, seconded by Council Member Fiedler, to direct the city attorney to determine whether Venice can influence the management of open burning activity within city limits and report back to council by September 2018.

Discussion followed on regulating open burning of land clearing debris from developments, monitoring activity, limiting burning hours, recommending the city attorney research if the city has ability to manage activity, air pollution ordinance, investigating what other counties are doing, land development regulations (LDR)s, burying land clearing debris in the required open space area, county code, recycling debris, impact to residents, urban forest trees, removal of invasive species on properties being developed, and date for the city attorney to report back to council.
