My name is Bill Schaid. I have been a resident of the Venetian Golf and River Club since 2011 and was recently elected President of the Property Owners Association of the Venetian Golf & River Club. Joining me today is Roger Effron, President of the Venetian Golf and River Club Community Association and a resident since 2006.

I am here today speaking on behalf of the Property Owners Association in collaboration with the Community Association, as both organizations are working together to represent the residents of our community. We believe that understanding our perspective is an important element of your decision as you amend the current Land Development Regulations.

We understand and appreciate the long hours that have been spent analyzing and developing revisions to the existing LDRs. We are not here to challenge the rights of developers who operate and take advantage of rights afforded to them under the law. Instead, we are here requesting that the Council ensure that any changes to the LDRs impose standards that must be met in any commercial developments that are located within residential zones.

As residents and homeowners of property in the city of Venice, you certainly appreciate the need to impose reasonable restrictions on the nature of commercial growth within our local, residential areas. The current draft of the proposed LDR revisions include some protective measures, such as height and density restrictions. However, homeowners need protection from commercial undertakings that significantly alter their residential landscape. The proposed Commercial Development for the Milano PUD is just that type of proposal. Though the amendment has yet to be filed, it has been workshopped and is to be located directly across from the entrance to the VG&RC. That represents a direct compatibility challenge to our quiet, mature neighborhood. The responsibility to protect neighborhoods from such intrusions lies directly in your hands. On behalf of residents throughout the City of Venice, please do not let us down as you make your decisions.
