An Ordinance Amending the Official Zoning Atlas of the City of Venice, Florida, Pursuant to Zoning Map Amendment Petition No. 24-05RZ, to Change the Zoning Designation on a Portion of the Property Located at 705 South Tamiami Trail (1.44 ± Acres), from Residential, Multi-Family 3 (RMF-3) to South Trail Area 2 (ST-2); Providing for Repeal of all Ordinances in Conflict Herewith; Providing for Severability; and Providing an Effective Date (Quasi-judicial)

Marty Black, being duly sworn, answered Council questions regarding the proposed stipulation, reaffirming no hotel in the front or back, prohibits a

hotel, heights, intensity, access to Guild Drive, and meeting residents' concerns.

- 3. Only multifamily residential uses and associated development parking shall be permitted on Lots 26, 27, and 28 of Block D, Country Club Estates Unit 2.
- 4. Vehicle access is prohibited from Guild Drive.
