23-6054 Approval of Letter to Sarasota County Commission for the Interlocal Parks
Agreement

Mr. Lavallee gave an overview of the correspondence to Sarasota County Commission, including Council's endorsement, and support of financial contributions to the park redevelopment, and use of impact fees.

A motion was made by Dr. Fiedler, seconded by Mr. Howard, to approve the letter to Sarasota County Commission for the Interlocal Parks Agreement and authorize the Mayor to sign it. The motion carried by the following vote:

23-6055 Request for City of Venice Representative on the United Way of South Sarasota County's Long Term Recovery Group Leadership Board (Mr. Longo)

Discussion took place regarding how the request for a liaison came about, there are many boards to take part in, and the Council's role in the board is as a representative, not one as a liaison.

A motion was made by Dr. Fiedler, seconded by Vice Mayor Boldt, to appoint Dick Longo as the City of Venice Representative on the United Way of South Sarasota County's Long Term Recovery Group Leadership Board. The motion carried by the following vote:

23-6056 Comprehensive Plan Strategy OS 1.4.4 - Non-Native Invasive Species (Dr. Fiedler)

Dr. Fiedler spoke on her request to change "should" to "shall."

Discussion took place about this only applying to City-owned property, and concerns regarding unintended consequences for neighbors of City-owned property.

Planning and Zoning Director Clark stated it would also apply to

developers, upon a development proposal and require them to remove invasives.

Discussion took place regarding previous situations where invasive species were allowed to be kept, and the current wording offering flexibility. If the verbiage was changed to "shall" would make it mandatory.

City Manager Lavallee spoke on the police station development, compatibility with the neighborhood, and allowance to keep Brazilian peppertrees, because both parties agreed.

City Attorney Fernandez answered a Council question regarding whether the City has a choice by state law. She noted property owners, including the City, would not necessarily be required to remove existing Brazilian Peppertrees, but state law prohibits planting them.

Dr. Fiedler withdrew her motion for further research.

A motion was made by Dr. Fiedler, seconded by Mrs. Frank, to direct staff to change the words "should" to "shall" in Strategy OS 1.4.4 of the Comprehensive Plan.

Dr. Fiedler withdrew her motion.
