Auburn Road and Border Road Owned by SSD Land Holdings, LLC, Rezoning the Property from Sarasota County Open Use Estate (OUE) to City of Venice Planned Unit Development (PUD); Providing for Repeal of all Ordinances in Conflict Herewith; Providing for Severability; and Providing for an Effective Date (Quasi Judicial)

Ms. Fernandez noted there were two requests for continuance filed and the city and applicant agreed to continue this item to August 28, 2019 at 9:00 a.m.

A motion was made by Council Member Fiedler, seconded by Council Member Daniels, to continue Ordinance No. 2019-26 to August 28, 2019 at 9:00 a.m. The motion carried unanimously by voice vote.

#### V. PRESENTATION

#### 19-4074

Jeff Shrum, AICP, Development Services Director and Kelley Klepper and James Taylor, Kimley-Horn & Associates, Inc.: Provide Exercise, Results and Explanation of the Transportation Modeling Project for Northeast Section (30 min.)

Mr. Shrum spoke on purpose of the northeast Venice neighborhood traffic study.

James Taylor, Kimley-Horn & Associates, Inc., provided a presentation and spoke on the study's scope, travel demand modeling, model refinements, significant growth by 2030, study area, and existing conditions of roadways.

Mr. Shrum commented on the Laurel Road segment from Knights Trail to Jacaranda Boulevard.

Mr. Taylor spoke regarding Sarasota County's data, roadway level of service (LOS), base 2030 model analysis, capacity deficiencies, and

refined future 2030 model analysis.

Mr. Shrum spoke regarding identified deficiencies on Knights Trail and Laurel Road.

Mr. Taylor spoke to future network scenarios, long range transportation plan (LRTP) improvements, and anticipated deficiencies.

Mr. Shrum commented on truck traffic on Laurel Road.

Mr. Taylor spoke on the new north/south public road 2030 model analysis and conclusions.

Mr. Shrum spoke regarding growth impact on roadways, updating the comprehensive plan and capital improvement schedule (CIS) to incorporate traffic study and prioritize projects, and Edmondson Road and Jacaranda Boulevard.

Discussion followed regarding Albee Farm Road, Metropolitan Planning Organization (MPO)'s model network, Laurel Road improvements, coordinating with Florida Department of Transportation (FDOT) and Sarasota County on the LRTP, capital improvement plan (CIP), Pinebrook Road and Venice Avenue intersection project, finance providing council with a projection on impact fees, staff providing council with a timeline and action plan to support the city's transportation study, and coordinating with the county on future projects.

Pat Neal, Neal Communities, spoke regarding Laurel Road improvements, relocation of water line owned by the Peace River Water Supply Authority, widening the median to accommodate the water line, Stantec Consulting's proposal, improvement costs, right-of way, Florida Power and Light (FPL) power lines, design bid process, financing, county incentive programs, Knights Trail, and public/private partnership with the city.

A motion was made by Vice Mayor Cautero, seconded by Council Member Gates, to direct staff to present to council a timeline and action plan to support the city's transportation study including setting priorities, securing intergovernmental support, and funding by September 10, 2019.

Discussion followed regarding public procurement process, including Capital City Consulting, and setting a deadline.

Mr. Lavallee noted staff can provide council with a timeline by September 10, 2019.

The motion carried unanimously by voice vote.

Recess was taken at 10:58 a.m. until 11:08 a.m.

#### VI. PUBLIC HEARINGS

#### CC 19-09CU

Consider and Act Upon Conditional Use Petition 19-09CU for the 300± Acre GCCF Planned Unit Development (PUD) Located East of I-75 Between Laurel Road and Border Road and Owned by Border Road Investments LLC, Myarra Property Joint Ventures LLC, Woolridge Investment-Florida LLC, and FC Laurel LLC to Allow for a Gated Community (Quasi Judicial)

Mayor Holic announced the ordinance and conditional use petition were postponed from the June 25, 2019 and will be done together with two separate motions, announced this is a quasi-judicial procedure, and re-opened the public hearing.

Ms. Fernandez questioned council on ex-parte communications and conflicts of interest since the last hearing. There were none.

Ms. Stelzer noted written communication received after the agenda was posted will be included in the agenda packet for the next hearing, and council received copies via email.

Mr. Shrum, being duly sworn, noted The Bridges and Villa Paradiso's binding master plans were included in the agenda packet and spoke to responding to the mayor's email of questions, zoning change request, and comprehensive plan language on building heights and architectural styles.

Mr. Clark, being duly sworn, spoke regarding revisions to amenity areas and stipulation requiring five percent of property be devoted to non-residential uses.

Discussion followed on the property's zoning and requested change, consistency with the comprehensive plan, The Bridges plan, and workforce housing.

Ms. Fernandez clarified the legal standard for council's decision today.

Discussion ensued regarding The Bridges property, affordable workforce housing, proposed density, public road, height concern, assisted living facility (ALF), comprehensive plan, reasons to change existing zoning, planned unit development (PUD)s, Villa Paradiso, commercial development in the northeast area, gated communities, traffic study, commercial mixed use (CMU), and developing affordable housing within the PUD.

Ms. Fernandez responded to council questions on maintaining the existing zoning and requiring workforce housing on the property.

Discussion continued on the rezone request and affordable housing.

Mr. Shrum clarified staff's stance on the ordinance with stipulations.

Recess was taken at 12:02 p.m. until 1:10 p.m.

Pat Neal, Neal Communities, being duly sworn, spoke to Neal Land and Neighborhoods home builders, GCCF PUD, demographics, proposed streetscape, native tree masses, density reduction, price range, affordable housing market, building houses that are attainable for Venice residents, commercial development on property, and ALF.

Jeffery Boone, Boone Law Firm, being duly sworn, spoke on proposed stipulations, request for the spine road to be gated, and desire to have a variety of architectural styles within the development.

Mr. Neal commented on the Mediterranean style to include costs.

Mr. Boone spoke regarding cell towers and requested language stating "existing cell tower facility" be stricken from the stipulation, noted conditional use petition for building height has not been filed and requested staff expedite the review process, and continued speaking on approved developments with city zoning, purpose for zoning change, workforce housing, and requested adding "proposed lakes" to the table in the binding master plan.

Jerry Jasper, 130 Burano Court, being duly sworn, spoke to council's previous action to move The Bridges property from the Laurel Road corridor to the northeast neighborhood.

Mr. Shrum reviewed stipulations in the ordinance and responded to council questions regarding building height stipulation, Northern Italian Renaissance architectural style requirement, and cell tower coverage.

Ms. Fernandez noted staff is researching if cell towers are considered an essential service.

Discussion followed regarding the utility right-of-way.

In response to council questions, Ms. Fernandez explained the cell tower footprint needs to be addressed before platting.

Discussion continued regarding building height stipulation, expedited review request, and transitional language in the comprehensive plan on

height and architectural styles.

Mayor Holic closed the public hearing.

Hurt, Trustees of the Shackett Creek Trust under Agreement dated November 25, 2002, into the Corporate Limits of the City of Venice, Florida, and Redefining the Boundary Lines of the City to Include said Additions; Providing for Repeal of All Ordinances in Conflict Herewith; Providing for Severability; and Providing for an Effective Date

Ms. Stelzer read the ordinance by title only.

Mayor Holic opened the public hearing.

Ms. Stelzer noted written communications were included in the agenda packet.

Mr. Boone stated no objection to hearing both annexations at once.

Council waived staff's and applicant's presentation.

Mr. Lavallee noted there has not been a county update on the proposed north/south connector road passing through the subject property.

Discussion followed regarding annexations and requesting direction on PUD layouts, PUD connectivity, code requirements, security in gated communities, and Rustic Road.

Mr. Shrum spoke to incorporating JPA amendment into the comprehensive plan.

Mr. Boone explained client is offering to improve Rustic Road by building a road and turning it over to the city or county to provide access west under I-75, and responded to council questions on the road being built to county standards.

Mr. Boone noted road infrastructure and improvements will be paid by the developer with no cost to the city.

Mr. Shrum noted permits needed for roadway improvements, reviewed issues raised by the county, and commented on improvements warranted by the traffic study, Knights Trail level of service (LOS), and state law and transportation standards.

Mr. Boone stated the JPA provides for the county to propose stipulations and the city is obligated to present those stipulations to the planning commission and council, and noted there are no stipulations from the county.

Discussion followed regarding county roadways, Curry Creek, areas with county water and sewer connections, providing reclaimed water service, Rustic Road and Ranch Road improvements, and Laurel Road and Knights Trail intersection.

Mr. Boone commented on the annexations and rezone application being consistent with state statutes, the city's comprehensive plan, LDRs, all

other applicable codes, and the JPA.

No one signed up to speak.

Discussion followed on the city's control over development, city revenue if developed in the county, no cost to taxpayers, and road connection benefitting city residents.
