Dave/Phil,

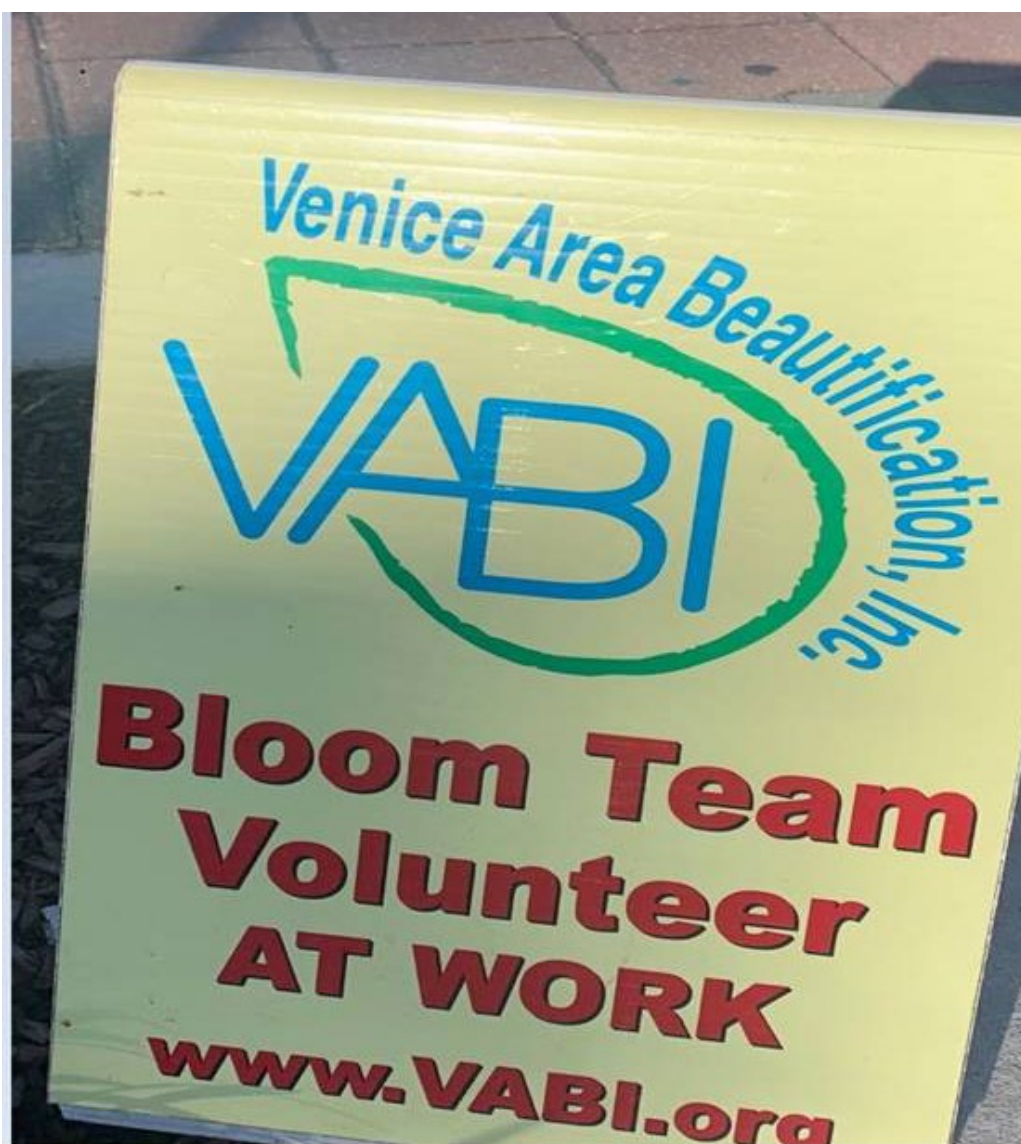
