

ORDINANCE NO. 2007-087

AN ORDINANCE OF THE COUNTY OF SARASOTA, FLORIDA, RELATING TO THE ONE PERCENT LOCAL GOVERNMENT INFRASTRUCTURE SALES TAX; PROVIDING FOR FINDINGS; PROVIDING FOR CONTINUATION OF THE CURRENT ONE PERCENT LOCAL GOVERNMENT INFRASTRUCTURE SALES TAX SUBJECT TO REFERENDUM APPROVAL; PROVIDING FOR ADDITIONAL CONTINUATIONS OF THE SALES TAX SUBJECT TO REFERENDUM APPROVAL; PROVIDING FOR THE DISTRIBUTION OF SALES TAX PROCEEDS; PROVIDING FOR THE ALLOCATION OF SALES TAX PROCEEDS; PROVIDING FOR CITIZEN TAX OVERSIGHT COMMITTEES; PROVIDING FOR A SPECIAL REFERENDUM ELECTION; PROVIDING FOR POLLING PLACES; PROVIDING FOR ELECTION OFFICIALS; PROVIDING FOR DATES AND HOURS FOR VOTING; PROVIDING FOR BALLOT QUESTION; PROVIDING FOR NOTICE OF ELECTION; PROVIDING FOR POSTING BY SUPERVISOR OF ELECTIONS; PROVIDING FOR CONSTRUCTION AND INTENT; PROVIDING FOR SEVERABILITY; PROVIDING FOR NOTIFICATION BY CLERK; PROVIDING FOR AN EFFECTIVE DATE; PROVIDING FOR REPEAL OF ORDINANCE NO. 2007-082.

BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF SARASOTA COUNTY, FLORIDA:

SECTION 1. FINDINGS. The Board of County Commissioners of Sarasota County, hereby makes the following findings:

A. Section 212.055(2), Florida Statutes, authorizes the Board of County Commissioners of Sarasota County (the "Board") to levy by ordinance a local government infrastructure sales tax of one percent (1%) throughout Sarasota County, Florida ("Sales Tax"), subject to referendum approval, to finance, plan and construct infrastructure, as defined in section 212.055(2)(d)(2), Florida Statutes, to acquire land for public recreation, conservation or protection of natural resources and to allocate Sales Tax proceeds to a trust fund within the County's accounts created for the purpose of funding economic development projects of a general public purpose targeted to improve local economies.

B. Pursuant to section 212.055(2), Florida Statutes, the Board adopted Ordinance No. 89-40, as amended, authorizing a Special Election on June 27, 1989 to obtain approval for the initial levy of a Sales Tax throughout Sarasota County. The voters approved the levy of the Sales Tax commencing September 1, 1989 for a period of ten (10) years, with the option of an additional five (5) years upon voter approval in a second referendum to be held at the end of the initial ten (10) year period.

C. Pursuant to section 212.055(2), Florida Statutes, the Board adopted Ordinance No. 97-083, as amended, authorizing a Special Election on November 4, 1997 to obtain approval for the continuation of the levy of the Sales Tax throughout Sarasota County for an additional ten (10) years, rather than five (5) years. The voters approved the continuation of the Sales Tax levy commencing September 1, 1999 for a period of ten (10) years, with the option to further continue the levy for an additional periods upon voter approval in a referendum to be held within two (2) years of the expiration of the then-existing Sales Tax.

D. The levy of the Sales Tax has enabled Sarasota County, municipalities within Sarasota County and the Sarasota County School Board (hereinafter referred to individually as the "Local Governing Body", or collectively as the "Local Governing Bodies") to raise a major portion of the revenue necessary to maintain acceptable levels of service for roads, parks, schools, public safety and other public facilities. Without adequate revenue, state law would require the Local Governing Bodies to lower their levels of service, directly impacting the quality of life in Sarasota County.

E. Pursuant to section 212.055(2), Florida Statutes, the Board has determined that it is in the best interests of the citizens of Sarasota County that the current levy of the Sales Tax be continued commencing September 1, 2009 through December 31, 2024, so as to enable the Local Governing Bodies to continue to provide the infrastructure necessary to maintain acceptable levels of service. The Sales Tax is paid by all those who benefit from infrastructure projects, including part-time and full-time residents, as well as visitors. The Sales Tax also provides a dependable revenue source that can be leveraged to get additional funding from other sources such as the State or granting agencies.

F. In an effort to identify and to evaluate the infrastructure needs of the community, each Local Governing Body obtained public input as to the identification of needed infrastructure projects and their prioritization. In addition, the Local Governing Bodies held infrastructure needs workshops at which staff presented reports related to on-going and future projects and activities. Based on this input, each Local Governing Body identified, ranked and allocated estimated Sales Tax proceeds to specific future projects.

G. It is in the best interests of the citizens of Sarasota County that each Local Governing Body continue the operation of their established Citizen Tax Oversight Committee (the "Committee") to ensure that the Local Governing Bodies follow the procedural requirements for changing Sales Tax projects or for reallocating the Sales Tax proceeds among projects, and to conduct an annual review of the Sales Tax expenditures.

SECTION 2. CONTINUATION OF THE SALES TAX. Pursuant to the provisions of Section 212.055(2), Florida Statutes, subject to approval of this Ordinance by a majority of electors of the County voting in a referendum on the Sales Tax, the one percent (1%) Local Government Infrastructure Sales Tax currently levied throughout Sarasota County, Florida shall be continued for a period commencing September 1, 2009 through December 31, 2024.

SECTION 3. ADDITIONAL CONTINUATIONS OF THE SALES TAX. Subject to approval by a majority of electors of Sarasota County voting in a referendum, the levy of the Sales Tax may be continued for additional periods. A referendum for continuance of the Sales Tax shall be held within two (2) years of the expiration of any existing Sales Tax. There shall be no prohibition against additional continuances; provided, however, that each continuance shall be subject to approval by a majority of electors of Sarasota County voting in a referendum.

SECTION 4. DISTRIBUTION OF SALES TAX PROCEEDS. The proceeds from the continued levy of the Sales Tax shall be distributed according to one of the following methods:

A. An interlocal agreement between the Board, the governing bodies of the municipalities representing a majority of the County's municipal population, and the School Board which shall provide that:

1. Twenty-five percent (25%) of the proceeds of the Sales Tax shall be distributed to the School Board of Sarasota County, Florida; and

2. The remaining proceeds of the Sales Tax shall be distributed among the County and municipalities in the same proportion that the population of each municipality and the unincorporated area of the County bears to the entire population of the County, as determined annually during the period of the levy of the Sales Tax pursuant to the latest official population estimates issued under Section 186.901, Florida Statutes; and

B. If there is no interlocal agreement, distribution of the proceeds of the Sales Tax shall be according to the formula provided in Section 218.62, Florida Statutes.

SECTION 5. ALLOCATION OF SALES TAX PROCEEDS.

A. Sarasota County

1. The proceeds from the levy of the continued Sales Tax received by Sarasota County are estimated over the period during which the continued Sales Tax is to be levied to amount to \$688,475,801 and shall be expended in compliance with Section 212.055(2), Florida Statutes. A minimum of fifty percent (50%) of the County's portion of the Sales Tax proceeds shall be allocated to roads and bridges (transportation), including, but not limited to such projects as replacement and rehabilitation; operations, safety and signalization improvements; roadway lighting; resurfacing; streetscapes; and sidewalks.

2. Pursuant to Section 212.055(2)(d)3, Florida Statutes, the County shall establish a trust fund within the County's accounts created for the purpose of funding with Sales Tax proceeds designated economic development projects of a general public purpose targeted to improve local economies.

3. A list of proposed projects with allocation of funds and implementation time frames for each project is attached hereto as Exhibit "A", and, by this reference, incorporated herein.

B. Sarasota County School Board

1. The proceeds from the levy of the continued Sales Tax received by the Sarasota County School Board, pursuant to the interlocal agreement provided for in Section 4 hereof, are estimated over the period during which the continued Sales Tax is to be levied to amount to \$351,482,015 and shall be expended in compliance with Section 212.055(2), Florida Statutes.

2. A list of proposed projects with allocation of funds and implementation time frames for each project is attached hereto as Exhibit "B" and, by this reference, incorporated herein.

C. City of North Port

1. The proceeds from the levy of the continued Sales Tax received by the City of North Port are estimated over the period during which the continued Sales Tax is to be levied to amount to \$145,509,844 and shall be expended in compliance with Section 212.055(2), Florida Statutes.

2. A list of proposed projects with allocation of funds and implementation time frames for each project is attached hereto as Exhibit "C" and, by this reference, incorporated herein.

D. City of Sarasota

1. The proceeds from the levy of the continued Sales Tax received by the City of Sarasota are estimated over the period during which the continued Sales Tax is levied to amount to \$144,955,116 and shall be expended in compliance with Section 212.055(2), Florida Statutes.

2. A list of proposed projects with allocation of funds and implementation time frames for each project is attached hereto as Exhibit "D" and, by this reference, incorporated herein.

E. City of Venice

1. The proceeds from the levy of the continued Sales Tax received by the City of Venice are estimated over the period during which the continued Sales Tax is levied to amount to \$62,975,648 and shall be expended in compliance with Section 212.055(2), Florida Statutes.

2. A list of proposed projects with allocation of funds and implementation time frames for each project is attached hereto as Exhibit "E" and, by this reference, incorporated herein.

F. Town of Longboat Key

1. The proceeds from the levy of the continued Sales Tax received by the Town of Longboat Key are estimated over the period during which the continued Sales Tax is levied to amount to \$12,529,636 and shall be expended in compliance with Section 212.055(2), Florida Statutes.

2. A list of proposed projects with allocation of funds and implementation time frames for each project is attached hereto as Exhibit "F" and, by this reference, incorporated herein.

G. Estimated Proceeds. The estimated proceeds from the levy of the continued Sales Tax are based upon revenue projections and are therefore contingent upon the actual receipt of funds and changes in population.

H. Modification to Projects and to Allocated Funding. Each Local Governing Body shall have authority, after a public hearing, to adopt by resolution changes to the infrastructure projects to be funded and to reallocate its share of the Sales Tax proceeds. Provided, however, that Sarasota County's allocation of Sales Tax proceeds among its project categories may be modified only upon a four-fifth's (4/5's) vote of the Board of County Commissioners. Each Committee shall ensure that its Local Governing Body has followed the procedural requirements for making changes to the infrastructure projects or to the allocation of Sales Tax proceeds.

SECTION 6. CITIZEN TAX OVERSIGHT COMMITTEES.

A. Continuation and Purpose. Upon approval of the referendum to continue the levy of the Sales Tax through December 31, 2024, each Local Governing Body shall continue the existence and operation of their currently established Citizen Tax Oversight Committee (the "Committee"). Each Committee shall continue to:

1. Conduct an annual review of the expenditures made by its Local Governing Body from the Sales Tax proceeds to ensure that expenditures have been made in accordance with infrastructure project lists and any changes thereto; and

2. Review any changes made by its Local Governing Body to the infrastructure projects or to the allocation of Sales Tax proceeds for the sole purpose of ensuring that all procedural requirements set forth herein have been followed.

B. Composition and Term.

1. Sarasota County

a. The County's Committee shall be composed of nine (9) Board-appointed members, residing in unincorporated Sarasota County. One (1) Committee member shall be appointed from each district by the Commissioner representing that district. Four (4) at-large Committee members shall be appointed by majority vote of the Board. Appointments shall be made for a term of four (4) years or until expiration of the Sales Tax and any continuations thereto, whichever shall first occur. Vacancies shall be filled for the remainder of the term in the same manner as the vacating member was appointed.

b. Committee organization and procedures shall be established by Board resolution.

2. Municipalities and School Board The composition of each Committee, terms of the Committee members, and Committee organization and procedures shall be established by resolution of the respective Local Governing Body.

C. Committee Assistance. Elected officials and staff of each Local Governing Body shall cooperate with its respective Committee to accomplish the objectives and purposes set forth in this Ordinance. Each Local Governing Body shall designate staff to provide administrative assistance to its Committee. Copies of reports and records relating to expenditures of the Sales Tax proceeds shall be made available to each Committee upon request.

SECTION 7. SPECIAL REFERENDUM ELECTION CALLED

A special referendum election is hereby ordered and called to be held throughout Sarasota County on November 6, 2007 for the purpose of submitting to the qualified electors residing within Sarasota County the question of whether this Ordinance and the continued levy of the Local Government Infrastructure Surtax shall be approved.

SECTION 8. POLLING PLACES The special referendum election shall be held at the polling places heretofore designated in Sarasota County, Florida.

SECTION 9. ELECTION OFFICIALS The election officials to conduct said election shall be appointed and certified by the Supervisor of Elections pursuant to applicable general law.

SECTION 10. DATES AND HOURS FOR VOTING. All qualified electors residing within Sarasota County may vote in said special referendum election. Absentee voting shall be permitted upon compliance with applicable provisions of general law.

A. Early Voting: Designated Early Voting sites shall be open Monday, October 22, 2007 through Sunday, November 4, 2007. Hours: Monday through Friday - 8:30 a.m. to 4:30 p.m.; Saturdays - 9:00 a.m. to 1:00 p.m. and Sundays - 1:00 p.m. to 5:00 p.m.

- B. Election day (November 6, 2007): The polls shall be open on the date of said special referendum election from 7:00 a.m. to 7:00 p.m.

SECTION 11. BALLOT QUESTION The ballot question to be voted upon in said special referendum election shall be in substantially the following form:

SECTION 12. NOTICE OF ELECTION The Clerk to the Board of County Commissioners shall publish a notice of said special referendum election in the Sarasota Herald Tribune, a newspaper of general circulation published in Sarasota County, Florida. Said notice shall be published once in the fifth week prior to the week of the special referendum election and once in the third week prior to the week of the special referendum election with the first publication to be at least thirty (30) days before the date of the special referendum election. Said notice shall be in substantially the following form:

Absentee voting will be permitted upon compliance with the applicable provisions of general law. A copy of Ordinance No. 2007- may be picked up at any one of the locations of the Sarasota County Supervisor of Elections: Sarasota County Terrace Building, 2001 Adams Lane, Sarasota, Florida; Biscayne Plaza, 13640 Tamiami Trail, North Port, Florida; or R.L. Anderson Administration Building, Room 114, 4000 South Tamiami Trail, Venice, Florida.

SECTION 13. POSTING BY THE SUPERVISOR OF ELECTIONS The Supervisor of Elections shall conspicuously post at each polling place during the hours that the polls are open a clean copy of proposed Ordinance 2007- 087.

SECTION 14. CONSTRUCTION AND INTENT

- A. The provisions of this Ordinance shall be construed together with Section 212.055(2), Florida Statutes.
- B. It is the specific intent of this Ordinance that the proceeds of the Sales Tax may be pledged for the purpose of servicing bond indebtedness incurred for bonds issued for infrastructure purposes, to the extent permitted by law.
- C. It is the further specific intent of this Ordinance that the terms and provisions of this Ordinance and Section 212.055(2), Florida Statutes, shall be construed liberally to achieve the public purpose of funding local infrastructure needs in order to carry out the intent of the Local Government, Comprehensive Planning and Land Development Regulation Act and, specifically, to maintain and to improve the quality of life of the residents of Sarasota County.

SECTION 15. SEVERABILITY

If any provision of this Ordinance or the application thereof to any person or circumstance is held invalid, the invalidity shall not affect other provisions or applications of the Ordinance which can be given effect without the invalid provision or application, and to this end the provisions of this Ordinance are declared severable.

SECTION 16. NOTIFICATION BY CLERK

- A. The Clerk of the Board of County Commissioners shall immediately notify the Sarasota County Supervisor of Elections of the adoption of this Ordinance and transmit a certified copy of this Ordinance to the Supervisor of Elections.
- B. The Clerk of the Board of County Commissioners shall notify the State of Florida Department of Revenue within ten (10) days after the adoption of this Ordinance. The notice shall be sent certified mail, return receipt requested, to: Florida Department of Revenue, P.O. Box 6609, Tallahassee, Florida 32314-6609, Attention: Revenue Accounting Section. The notice shall include the date on which collection of the continued levy of the Sales Tax will commence, the time period during which the surtax will be in effect, the rate, a copy of this Ordinance, and such other information as the Department of Revenue may prescribe by rule.
- C. The Clerk of the Board of County Commissioners shall immediately notify the State of Florida Department of Revenue of the results of the special referendum election provided for herein.

SECTION 17. EFFECTIVE DATE

- A. Pursuant to Section 125.66, Florida Statutes, a certified copy of this Ordinance shall be filed with the Department of State by the Clerk of the Board of County Commissioners within ten (10) days after enactment by the Board of County Commissioners. For purposes of calling the Special Election, this Ordinance shall take effect when filed with the Department of State. Subject to Section 17.B below, for purposes of authorizing the continuation of the levy of the Infrastructure Sales Tax, this Ordinance shall take effect on January 1, 2009.
- B. The continuation of the levy of the Sales Tax proposed by this Ordinance shall become effective September 1, 2009, only if approved by a "yes" vote by a majority of those voting on the question posed at the November 6, 2007 referendum. If a majority of those voting on the question posed do not vote "yes", the proposed continuation of the levy shall not be authorized.

SECTION 18. REPEAL

This Ordinance repeals and replaces Ordinance No. 2007-082.
