The Maxine Barritt Park

Maxine Barritt was the single individual directly responsible for the city of Venice setting aside the waste water treatment plant property for the citizens of Venice and Sarasota County. It was Mrs. Barritt who rescued this land from developers for the citizens of Venice. She worked unstintingly from 2003 until her death on February 14, 2009 to see the fruition of this park for all of us. Maxine Barritt spearheaded the movement for the park. She went door to door collecting signatures. Over 3,000 signatures were collected. The original petition read:

We the undersigned, petition the city of Venice to, under no circumstances, sell/lease the island waste water treatment plant to any developer and: furthermore, to take the necessary procedures to convert the property into a park for all citizens to enjoy.

One of the 4 items listed on the bond issue the citizens of Venice voted for was the purchasing of Tramonto Vista Park. The public support for this park was one of the motivating factors in the bond issue being passed. Maxine also served on the one cent sales tax board and the bond oversight board and was very active in both positions.

Mr.. Boone questions any naming of the park after a person. He suggests that a criteria, or standard, be set up, if the park is to be named for an individual. First of all, we already have numerous places in Sarasota named after people. For example, The Robert Anderson Building, the Georgia and Michael Miller YMCA building. Higel Park, John Nolen Park, Blalock Park, Casperson Beach, etc. Secondly, in the past, naming has been based on a person's political activism, monetary contribution, connection to a person in power, etc. We, the citizens of the City of Venice and Sarasota County, feel that naming the park after Maxine Barritt, a dedicated non paid community activist directly responsible for the acquisition of the park is a very commendable criteria, or standard. **Ours is a nonpolitical, grassroots movement!** Over 20 volunteers, within less than four weeks, have collected over 900 signatures signatures to name the park after Mrs. Barritt.

We have chosen to submit these petitions to city council today, before the renaming of Tramonto Vista Park is officially completed. If we had more time, undoubtedly, we could have collected many more signatures. It is our hope that the City Council will respond to the strong feelings of the residents of Venice and Sarasota County whom they represent and will rename Tramonto Vista Park the Maxine Barritt Park.

(3:15) Lois Regan, 1228 Pine Needle Road, spoke in favor of renaming Tramonto Vista Park to Maxine Barritt Park.

Rosemary Vauzanges, 536 Riviera, expressed her delight with the abundant number of public parks in the city and spoke in favor of renaming the Tramonto Vista Park to Maxine Barritt Park.

Imogene Rigdon, 118 Treviso Court, spoke in favor to rename Tramonto Vista Park to Maxine Barritt Park.

IV. NEW BUSINESS

1. Policy Recommendation – Nomination of Environmentally Sensitive and Neighborhood Park Lands – Mary Holcombe, Assistant City Manager

Ms. Holcombe gave a brief introduction regarding the nomination concept, emphasized this policy is not intended to circumvent the right of any citizen to make a recommendation or nomination directly to Sarasota County, and noted the on-line nomination form on the www.scgov.net website. She explained the intent of the policy is to ensure a staff review is completed and recommendations are available to city council should a citizen request city council endorsement. She outlined the city's procedure that includes filing an application with the planning and zoning department and staff involvement in the nomination through the Technical Review Committee (TRC). She went on to say if the nomination is consistent with the city's goals and objectives and is approved by the TRC, then the application would be presented to the Parks and Recreation Board followed by the Planning Commission and then City Council. If the application is not approved it would be returned to the applicant with an explanation of the outstanding issues and told they could proceed to the county if they desire.

Ms. Holcombe stated the last step in the process is the city manager submits a letter to Mr. McCarthy at the county stating the city endorses the application, and reiterated each step would require board approval.

Ms. Holcombe answered questions regarding the location being more than five miles from an existing park or preserve and the effect of this procedure on the Blue Haven proposal.

Discussion ensued regarding the five mile county criteria and water service to parks.

(3:32) There was a **consensus** to approve the form and procedure for the nomination of environmentally sensitive and neighborhood park lands.

2. Renaming of Tramonto Vista Park to Maxine Barritt Park - Gary Budway

Mr. Budway reviewed his cover letter and application for the renaming of a park, stated he serves on the Citizens Tax and Bond Committees, and noted the number of citizens that were in favor of renaming Tramonto Vista Park to Maxine Barritt Park. He summarized the number of years Ms. Barritt worked on the acquisition and development of the park, and expressed his

support to have Tramonto Vista Park renamed to Maxine Barritt Park. Mr. Budway stated the final plans for the park have not been disclosed, talked about the funding for the park, and stated regardless of what the board does today, this request will move forward to council.

Chair Andrews reviewed the Tramonto Vista Park presentation given by Assistant City Engineer Kathleen Weeden, who reported ground breaking will commence in June 2009 with a completion date of June 2010. He queried the board on the two requests received to rename Tramonto Vista Park to either Clark Recreational Park or Maxine Barritt Park.

Discussion followed regarding the consideration of this name change, the past recommendation of Clark Recreational Park, delaying a decision on this until next month, additional information on other options, council hearing both options, the official name change occurring later in the process due to grants and permits under the Tramonto Vista name, council being aware of both name recommendations, a possible motion to forward the request to council without board approval, and allowing city council to determine the park name.

(3:51) Mr. Gelormino **moved** the proposal for the Tramonto Vista Park name change to Maxine Barritt Park be forwarded to council without a recommendation from the Parks and Recreation Advisory Board, and for council to make the final decision on the name of the park. **Seconded** by Ms. Silk. MOTION CARRIED WITH SIX IN FAVOR AND TWO OPPOSED.

Mr. McKeon answered questions regarding the Tree City USA proposal being communicated to city council.

Mr. McKeon left the meeting at 3:54 p.m.

3. Park Appreciation Day – Monty Andrews

Mr. Andrews proposed the board discuss the establishment of Park Appreciation Day to be held annually in Venice in conjunction with Earth Day on April 22. He commented on the county efforts to promote park usage with a slogan or motto, such as "it starts in the parks" and suggested the city have their own slogan to promote city parks.

Discussion followed regarding including all the parks, Earth Day event at the community center, picking one park that people frequent, promoting unused parks, fitness equipment or mile markers on walking paths, utilization of parks, handing out park brochures to educate the public, the city park system encompassing the community center, library and art center, and having the first Park Appreciation Day this year.

There was a consensus to promote a Park Appreciation Day in Venice.

Discussion continued regarding the time frame for a Park Appreciation Day resolution and promoting parks immediately.

Renaming of Parks

At the February 9, 2009 meeting of the City of Venice Parks and Recreation Advisory Board, the members voted to submit an application to rename Tramonto Visa Park. The requested name was the Clark Recreation Center. The application was made by Ms. Dawn Stoddart, a member of the Parks and Recreation Advisory Board and the granddaughter of Mr. Clark. On March 16, 2009 Mr. Gary Budway reviewed an application with the Parks and Recreation Advisory Board to rename the Tramonto Visa Park to the Maxine Barritt Park. The Board voted to forward the request to City Council without a recommendation. During Audience Participation at the April 14, 2009 City Council Meeting, Mr. Budway requested that the renaming of Tramonto Vista Park be placed as an agenda item on the April 28, 2009 City Council Meeting agenda. The applications submitted by Ms. Stoddart and Mr. Budway are attached.

During Council Reports at the March 24, 2009 City Council Meeting, Mr. McKeon informed City Council of both applications and of the Parks and Recreation Advisory Board's actions. At that time, it was determined that Mr. McKeon would work with staff regarding the rules of order for the renaming process and the City Manager would look for alternatives, such as naming specific areas in the park after an individual.

Subsequently two City Council members (Ms. Lang and Mr. Zavodnyik) have requested that this item be placed on the April 28, 2009 City Council agenda.

City Council Options:

The following options are available for your consideration:

- 1. Rename the park for one of the individuals requested.
- 2. Name a section of the park after one of the suggested individuals. (The tentative plans include a large gazebo/pavilion.)
- 3. Name a section of Heritage Park in honor of one of the individuals.
- 4. Place a commemorative plaque in Heritage Park in honor of one of the individuals.
- 5. Rename another existing park in honor of one of the individuals.
