AFFIDAVIT OF NON-COMPLIANCE

BEFORE ME, the undersigned authority, personally appeared Michael J. Halpin, City of Venice Code Enforcement Officer, who was sworn and says:

- 1. Pursuant to Section 2-333 of the City of Venice Code of Ordinances ("City Code"), Respondent was issued (3) Civil Citations on November 19, 2024, for a violation of Code of Ordinances Subpart B/Land Development/Chapter 88 Building Regulations/Section 4. Contractors. 88 4.1.2 Unlicensed Contractor, Class IV penalty; Chapter 88 4.2 Contractor Registration, Class II penalty; and Chapter 88 4.2.4 Unpermitted Work, Class II penalty.

- 4. In addition to any penalty imposed, pursuant to Section 2-328(d) of the City Code, if the City prevails in prosecuting the case it shall be entitled to recover all costs incurred in prosecuting the case before the Special Magistrate.
- 5. Respondent may pay the Citation penalty prior to the February 5, 2025, Special Magistrate meeting by contacting the Code Enforcement Officer. If paid in full, the case will not be heard by the Special Magistrate and no judgment will be entered against the Respondent.

NOTICE: If you are going to be represented by an attorney, that attorney should file a Notice of Appearance with the Special Magistrate prior to the meeting, at 401 W. Venice Ave, Venice, Florida 34285.
