1. Approval of Minutes from the January 8, 2013 and January 22, 2013 Regular Meetings

2. Approve Execution of the Agreement for Consulting Services between the City of Venice and Kimley-Horn and Associates to Conduct a Downtown Mobility Study in the Amount of \$240,000

Ms. Weeden answered questions concerning project funding, the city being the project manager, contract approval process, including input by council members in the project scope, Sarasota County Area Transit (SCAT) extending bus routes to Sharky's Restaurant and the Crow's Nest Restaurant, trolley service, wayfinding signage, transportation service to workforce housing, scheduling of traffic counts during season, downtown parking, bus shelters, bike lanes, Mobility Study timeline, sharing information with Sarasota County government and the Tourist Development Council, providing updates to city boards and Venice MainStreet, prior studies, updating council on the progress of all studies, looking for cost savings, meeting conditions for federal funding, and tracking study results and impacts.

Marketing and Communications

1. Approve Fiscal Year 2013 Federal Appropriations Requests

Mr. Lavallee provided a review of the requests and answered questions relating to justification for the combined fire and police complex.

Public Works

1. Approve Street Lighting Agreement with FPL for Cobra Head Street Light at 1301 East Gate Drive

Mr. Lavallee reviewed this item.

Ms. Weeden answered questions concerning energy efficient light options, long range city street lighting.
