Ms. Fernandez referenced Executive Order No. 20-69 issued by Governor DeSantis and Executive Order No. 2020-04 issued by the city regarding public meetings, and commented on public participation in public meetings.

C. COUNCIL ACTION/DISCUSSION

20-4481 Response and Actions Related to COVID-19

Mr. Lavallee commented on communication with Sarasota County Emergency Operations Center (EOC) and COVID-19 reports sent to staff on a daily basis, food trucks licensed by the state operating remotely, availability of the Venice Community Center (VCC), employees working from home, virtual and on-site meetings, beach openings and parking access, and requested council's input on beach parking.

Discussion followed on mirroring the county for public safety.

Mr. Lavallee spoke on circumstances that led to beach closures.

Discussion ensued on opening beach parking lots on a limited basis, the governing authority to open parking lots during emergency conditions, residents following current guidelines, nearby street parking, including beach parking information on the city's website, opening handicap parking spaces, Nokomis and Venice beaches, keeping in sync with the county, and providing accessible handicap parking.

Mr. Lavallee confirmed only handicap parking will be allowed at the beach, and noted he will convey the city's position to the county.

Chief Carvey reported on the spike in positive COVID-19 tests, public test sites throughout the county, hospital capacity, and personal protective equipment (PPE) shipment and shortage.

Discussion continued regarding the increase in positive COVID-19 cases.

20-4482 Direct Staff to Research and Develop Minimum Standards for External Appearance of Vacant Buildings in Downtown Area (Feinsod)

Mayor Feinsod spoke on his observations of sidewalk conditions and external appearance of vacant storefronts.

Discussion followed regarding establishing minimum standards for building aesthetics, working with downtown property owners, incorporating standards in the land development regulations (LDRs), the city's sign

ordinance, and partnering with VMS to help develop standards.

A motion was made by Mayor Feinsod, seconded by Dr. Fiedler, to approve Item No. 20-4482. The motion carried by the following vote:

<u>20-4483</u> Finance Director Linda Senne: Quarterly Financial Update (10 min.)

Ms. Senne reviewed FY20 general fund revenues, budget, expenses, unassigned fund balance, and reserves.

Discussion followed regarding general fund reserves, conserving cash, delaying uncommitted capital projects, hiring freeze, retaining fleet vehicles, prioritizing city expenses, adopting a flexible budget for FY21, contingency plan to mitigate revenue losses, cash conservation fund, economic recovery, and the city's eligibility for federal aid.

A motion was made by Council Member Cautero, seconded by Vice Mayor Newsom, for staff to present council with cash conserving options for FY20, and continue process for the FY21 budget. The motion carried unanimously by voice vote.

Discussion continued on staff's timeframe to provide information to council.

Ms. Senne commented on capital projects in the general fund.

Discussion ensued regarding uncommitted capital expenditures in the general fund, cash savings, reviewing and freezing open positions, tax revenues, one-cent sales tax revenue, budget projections, prioritizing capital projects for FY21, hiring freeze, and projects funded by the one-cent sales tax.

Ms. Senne commented on the one-cent sales tax fund.
