Suzette Coates, 612 Barcelona Avenue, discussed concerns with speeding on her street.

Mike Pachota, 213 The Esplanade South, thanked Council for relationship with his business.

Justin Pachota, 713 Laguna, commented on the teamwork between his business and the City and discussed concerns about parking lot maintenance, pier maintenance, beach maintenance, more charging stations, solar projects, workforce housing, and staffing challenges.

Ed Martin, 409 Everglades, spoke against building height increases in downtown Venice.

Lisa Jarvio, 231 Airport Avenue, spoke against building height increases.

Dawn Champiny, 610 Barcelona Avenue, spoke against building height increases and speeding on her street.

Bryan Harrison, 911A Gibbs, spoke against increasing building heights, requests for exceptions and demolitions to go before Council, and opposition to combining the Historic Preservation (HPB) and Architectural Review Boards (ARB). An Ordinance of the City of Venice, Florida, Amending the 2017-2027

#### VI. UNFINISHED BUSINESS

22-5503 Update on Habitat for Humanity Two Acre Parcel Located at 749 Knights Trail Road (City Manager)

Dr. Fiedler made a motion, seconded by Dr. Neunder to authorize staff to negotiate agreement with Habitat for Humanity to allow for the sale of the property located at 749 Knights Trail Road, with all proceeds to be made available for Habitat for Humanity and dedicated to creating affordable housing projects within the City of Venice.

John Holic, 636 Apalachicola Road, spoke regarding the property at 749 Knights Trail Road, reviewed the history of the property in relation to Habitat for Humanity ownership, noted opposition to Habitat selling the property, and stated if the land is sold the City should keep the funds.

Joe Dalton, 105 Bluegrass Court, Nokomis, spoke on behalf of Habitat and issues with building on the property and the need for affordable housing.

Michael Sollito, 4251 Conrad Road, spoke regarding the challenges with property development as it relates to the Portofino agreement.

Discussion took place regarding sale of the property, requirements for number of units, parcel being donated to the City, proceeds from a potential sale staying in the City and under City control, splitting funds, potential stipulations on how the funds should be handled, making Habitat whole financially, and presenting options for Council to choose from at a future meeting.

Mr. Lavallee offered options to be considered in regards to the parcel.

Ms. Moore called the question.

Dr. Fiedler rescinded her motion.

Mr. Boldt requested the matter be placed on the agenda for the next meeting.

City Attorney Fernandez clarified that staff would wait for Council to bring back ideas of what they would like included when drafting and negotiating an agreement.

There was consensus to have staff bring back an ordinance incorporating amendments as discussed, including City Manager Lavallee's changes and removing a health insurance subsidy.

Mr. Boldt discussed the impetus for this amendment.
