After reviewing the town calendar with you;

Turn left onto Nokomis to Santa Maria
Turn left onto Santa Maria to Nassau
Turn left onto Nassau
Finish at Epiphany Cathedral Parking lot

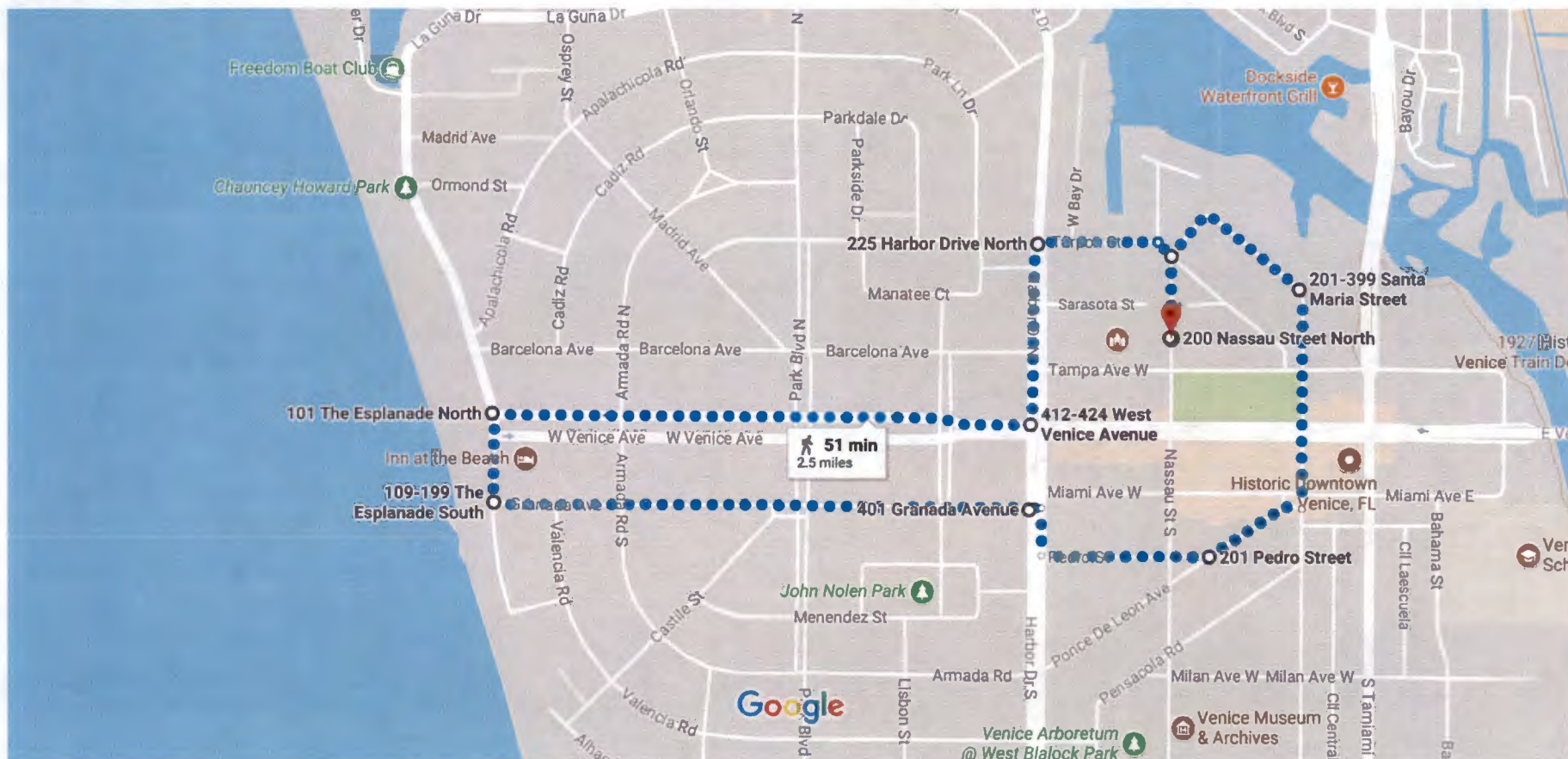
