- 1. Summary of the proposed ordinance (must include a statement of the public purpose, such as serving the public health, safety, morals, and welfare): The City of Venice has a Police Pension Plan which provides benefits for retired Police Officers. This has been a necessary feature of employment for Police Officers, whose employment is necessary to maintain law and order. This Ordinance contains three proposed amendments to the Plan. The first is an amendment of the definition of 'Salary'; adding language to clarify the determination period for maximum annual compensation for members who leave the service of the City and have completed less than 12 months of service during a fiscal year as provided for in the Internal Revenue Code. The second is an amendment to language regarding Police Pension Plan Board discretion on seeking recovery of inadvertent overpayments from the Fund, as permitted by the Secure Act 2.0. The third is an amendment to the Minimum Distribution of Benefits section, changing the required distribution age from 72 to the applicable age provided for in the Internal Revenue Code, as amended from time to time.
