## **RESOLUTION NO. 2013-15**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF VENICE, SARASOTA COUNTY, FLORIDA CONVEYING A PERPETUAL EASEMENT TO THE STATE OF FLORIDA DEPARTMENT OF TRANSPORTATION FOR THE US 41 BYPASS PROJECT; AND PROVIDING FOR AN EFFECTIVE DATE.

**WHEREAS**, the State of Florida Department of Transportation proposes to construct or improve State Road No. 45-A (US 41), Section No. 17180-000, in Sarasota County, Florida; and

**WHEREAS**, it is necessary that an easement across certain lands now owned by the City of Venice, Florida, be acquired by the State of Florida Department of Transportation; and

WHEREAS, said use is in the best interest of the city; and

WHEREAS, the State of Florida Department of Transportation has made application to said city to execute and deliver to the State of Florida Department of Transportation a perpetual easement, in favor of the State of Florida Department of Transportation, for the purpose of constructing and maintaining a box culvert and channel slope erosion control fabric at Hatchett Creek, and said request having been duly considered.
