Presentation Of Guidelines for Legacy Award And Seeking Approval To Establish the Program

Historical Resources Manager Klinkhamer presented new proposed guidelines, two cataogories of Historical Preservation and Historical Achievement, new subcategories, applicant requirements, and opening up nominations from public.

Discussion took place regarding opening nominations up for community participation, past focus on individuals, concerns for new construction language, modeling language similar to National Historic Preservation guideline, adding language for parks or landscaping considerations, being able to amend guidelines in future if needed, timelines, presenting during historic preservation month in May, accepting applications year round, and how the winners will be recognized.

A motion was made by Mr. Weaver, seconded by Ms. Trammell, to approve the new guidelines with the suggested changes. The motion carried unanimously by voice vote.

PLAR24-002

649 S Tamiami Trail - Requesting Variance to Allow Metal Roof in the Venetian Theme Architectural Control District

Staff: Brittany Smith, Planner

Applicant: Bernard Doogue, Condo Association Manager Owner: Country Club Apartments Condo Association, Inc.

Chair Beebe announced this is a quasi-judicial hearing, and opened the public hearing. Recording Secretary Hawkins-Brown read the memorandum regarding advertisement, and written communications.

Assistant City Attorney Lewis questioned Board members concerning ex-parte communications and conflicts of interest. There were none.

Planner Smith, being duly sworn, presented general information, aerial map, site photos, replacement of asphalt roof to new seam metal roof, criteria for variance, street view of property, neighboring property roof, building being built before architectural requirements were applied in 2005, and answered Board's question on construction date of buildings.

Bernard Doogue, Applicant, and James Robinson, Contractor, both being duly sworn, presented reason for roof replacement, selection of contractor, and answered Board questions on color, sheen of finish, visibility from street, cost to add the color coating, whether the applicant considered

metal barrel tile style roofing, slope of project, and color coating options.

Discussion took place regarding visibility, the recent change in architectural requirements for area, mixing styles on building, consideration of cost, textured coating, and concern for sheen of product.

Assistant City Attorney Lewis clarified the variance standards.

Planning and Zoning Director Clark spoke on history of architectural requirements in area, decision criteria, and area's transition to Venice Historic Precedent (VHP) style.

Discussion continued regarding concerns for mixing styles on single building, and additional cost to applicant for tile roof.

There was no public comment.

Chair Beebe closed the public hearing.

A motion was made by Ms. Trammell, seconded by Ms. Dearybury, that based on the presentation, the Historic and Architectural Preservation Board moves to approve Application No. PLAR24-000282. The motion carried by the following roll call vote:

PLAR24-002 83 901 S Tamiami Trail - Requesting Variance to Allow a Metal Roof in the

Venetian Theme Architectural Control District

Applicant: Crowther Roofing & Cooling

Owner: Venice Medical Center Condo Association, Inc.

Chair announced this is a quasi-judicial hearing, and opened the public hearing. Recording Secretary Hawkins-Brown read the memorandum regarding advertisement, and written communications.

Assistant City Attorney Lewis questioned Board members concerning ex-parte communications and conflicts of interest. There were none.

Planner Smith, being duly sworn, presented general information, aerial map, replacement of flat concrete tile roof for a metal roof, variance requested after the roof replacement was completed, replacement done between Hurricanes to secure property, site photo, photo prior to roof replacement, structure was built during 1970s, predating theme requirements, building style, decision criteria, and surrounding property details.

Chris Dowd, Contractor, being duly sworn, presented roof replacement, building use, partnership with general contractor, issue with permitting, recent projects done in area, being unaware of architectural requirements at the time, photo of finished product, color of roofing, sheen of finish, material used, and longevity of metal roof material.

There was no public comment.

Discussion took place regarding recently expansion of theme district to include property, and letter from Dr. Gress.

Chair Beebe closed the public hearing.

Discussion took place regarding the applicant's hardship, visibility, quality of material, and in favor of color selection.

A motion was made by Mr. Barrick, seconded by Ms. Dearybury, that based on the presentation, the Historic and Architectural Preservation Board moves to approve Application No. PLAR24-000283. The motion carried by the following roll call vote:
