


## PERMANENT STRUCTURE IN RIGHT-OF-WAY BOND

KNOW ALL MEN BY THESE PRESENTS, that Kyla Scheic
herein called "Owner", is held and firmly bound unto the City of Venice, a municipal corporation, herein called "City", in the full and just sum of Twenty nine thousant for harder for \$\frac{1}{2} \frac{1}{2} \
WHEREAS, the Owner, to secure this obligation, has deposited with the City, the sum of \$\frac{29, 446.40}{\text{o}}\$, which sum shall be held in a special account at a local bank or savings and loan association until this obligation is satisfied; and
WHEREAS, the Owner is constructing a permanent structure or improvements within the City right-of-way, as identified in City Permit No. ENRU20-00335, and depicted on EXHIBIT A attached hereto (hereinafter referred to as "the Structure"); and
WHEREAS, as a condition of the permit Owner has agreed to execute this bond.
NOW, THEREFORE, THE CONDITION OF THIS OBLIGATION IS, that if the Owner completes the construction of the Structure in accordance with the permit and promptly makes payment of all persons supplying the Owner or his contractors and subcontractors any labor, services, material or supplies used directly or indirectly in the prosecution of the work, and further that if the Owner shall pay any and all costs or expenses incidental to the performance of all work required to be performed hereunder, then this obligation shall be void and the cash deposit returned to the Owner; otherwise it shall remain in full force and effect.
In the event the Owner fails to satisfactorily perform any construction work required herein within fifteen (15) days of a written request from the City, then the Owner shall be in default and the City shall have, in addition to all other rights, the immediate right to make or cause to be made, any such construction work or removal of the Structure and pay all costs, both direct and incidental, from the proceeds of this bond.
The City shall be entitled to its reasonable attorney's fees and costs in any action at law or equity, including appellate court actions, to enforce the City's rights under this bond.
