I. PUBLIC HEARING

13-0125 Consideration of a Proposed Millage Rate for Year Ending December

31, 2013

Mr. Snyder briefed council members on regulations for newspaper advertising of enhancements to the fiscal 2014 budget, and also

provided an overview of those enhancements.

Council members discussed the need for better communication of the

budget process.

13-0126 Tentative Budget, Fiscal Year 2013-2014

Ms. Stelzer read the taxing authority statement and Mayor Holic opened

the public hearing.

Ms. Stelzer said no written communication was received.

Janice Collins, 908 Riviera Street, suggested running side-by-side ads in

order to simplify budget numbers.

Mayor Holic directed Mr. Snyder to research this suggestion to assure this would not violate state laws.
