NOW THEREFORE, in consideration of the premises and mutual covenants contained in the <u>July</u> <u>13, 2010</u> Agreement and in this Work Assignment, the parties agree as follows:

- 1. General description of the project Provide additional construction inspection services for the Water Main Replacement (Phase I) project as described in the attached scope of services.
- 2. Scope of services to be performed. CONSULTANT shall perform the services described in Attachment "A".
- 3. As the OWNER and the CONSULTANT agree that the services will be contracted under this Change Order No. 1 at an additional compensation of \$27,600, as set forth in Attachment "A" bringing the total compensation \$155,200 for performance of the professional services specified in this work assignment.
- 4. Time for completion. CONSULTANT shall complete the professional services specified in this work assignment in accordance with the project construction schedule.

ATTACHMENT "A"

SCOPE OF SERVICES WORK ASSIGNMENT NO. 3

Revised "As-Needed" Inspection Services

BACKGROUND

The City of Venice (OWNER) has requested Hazen and Sawyer (CONSULTANT) to provide additional construction inspection services associated with the Phase 1 Water Main replacement project. The revision is being provided to amend the hours required for this project; no other changes have been made and the scope of services shall remain the same as noted below.

SCOPE OF SERVICES:

No changes at this time

COMPENSATION (REV 1):

This revision includes an increase fee of \$27,600 for additional inspection associated with the Phase 1 Water Main Replacement project. The initial fee estimate was based on providing 60 days of active inspection at 4 hrs/day. However, the project schedule includes 240 days for construction and it is estimated that additional time will be required to provide approximately 120 days of active inspection in lieu of 60 days. This is necessary due to the criticality and sensitivity of the project. This will result is a revised total of \$155,200.

All other aspects of this Work Assignment shall remain the same: The CONSULTANT shall be paid for this Work Assignment using a "Standard Hourly Rate" basis in accordance based on the scope above and the budget breakdown provided in the revised Table 1, Fee Schedule. All invoices shall be due and payable monthly and will be accompanied by a monthly status report that outlines the work performed for each task and the number of hours spent on each project. The budget associated with each task item will not be exceeded without the CITY's written approval.

Since the actual construction periods for these projects are not known, this work will be performed in coordination with the OWNER.
