

Wellfield Regional Park Improvements Update

Joint Meeting May 16, 2025





Background

- Since 2018, the County and City of Venice have been discussing a new interlocal agreement with a focus on the County's role as a regional park provider as outlined in the 2016 Parks Master Plan and the transition of non-regional parks back to the City for operations.
- Interlocal Negotiation Strategy:
 - 1. Improving Staff-level Relationships
 - 2. Joint Capital Parks Planning and Joint Projects
 - 3. Accepting City/County Park Management Roles
 - 4. Emergency Collaboration





Background

- The future of Wellfield Park was a focal point in the City and County negotiations.
- Significant athletic facility serving the mid-county region.
- Cost-sharing became key to upgrade this facility and offer mutual benefit to both City and County.
- Positive Board support and collaboration.
- In the Fall of 2024, both Boards approved the new parks interlocal agreement between the City of Venice and Sarasota County, an agreement for conveyance of Wellfield Park and a funding agreement for the redevelopment of Wellfield Park as a Regional Park.





Interlocal Agreement

- The new interlocal agreement takes effect on October 1, 2026, at the end of the term of the existing interlocal agreement and includes:
 - The County continuing operation of the Designated Regional City Parks, including the beaches and Marina Park and Boat Ramp in the Interlocal.
 - The return of seven parks to the City of Venice for operations.
 - Continued operation of Pinebrook Park as an extension of Wellfield Park.
 - Chuck Reiter Park will be returned to City operations no later than October 1, 2029.
- The term of the interlocal agreement is ten years, commencing on October 1, 2026, and shall be automatically renewed in two additional five-year increments.





Conveyance Agreement

- The Agreement for Conveyance of Real Property describes the transfer of the Wellfield Park property from the City to the County, subject to easements, reservations and restrictions of record.
- The County has agreed to perpetually operate the Regional Park
 Property as a regional athletic park, consistent with its current use
 subject to appropriations for funding and budgetary considerations.
- Upon closing and conveyance of Wellfield Park to the County, all operations, maintenance, repair and replacement including capital improvements will become the responsibility of Sarasota County.





Funding Agreement

- The Funding Agreement for Wellfield Park/Regional Park Project describes the partnership between the County and the City and sets forth the specific funding associated with the redevelopment project, which is estimated to cost a minimum of \$40 million.
- The City has agreed to provide funding in the amount of \$20 million for the Regional Park Project.
- The County has agreed to provide a minimum of \$20 million for the development of the Regional Park.

Wellfield Regional Park Improvements Project

- Wellfield Park currently has aging infrastructure with many amenities and facilities at end of life and in need of complete replacement.
- A CIP project to prepare for design and pre-construction services following successful conveyance of the park property has been established.
- The CIP project will include planning, design and permitting to reorganize and redevelop the park into the south county regional sports complex.





Regional Park Project Milestones and Timeline

- Solicit and award design and construction manager contracts
 Fall 2025
- Begin initial master/concept planning and community engagement Late 2025 - Early 2026
- Design and Permitting
 Spring 2026 Spring 2027
- Begin Phased Construction
 Spring 2027





Community Engagement and Master Planning

Community engagement will be key to the successful redevelopment of Wellfield Park and the surrounding parks and preserves.

- Wellfield Park
 - Optimization and efficiency of space allocation
 - Modernization of facilities and understanding changes in youth sports
 - Increasing sports tourism opportunities
- Pinebrook Park
 - Connectivity and parking
 - Possible relocation, replacement, or development of amenities
- Bypass Park/Foxworthy Campus
 - Complementary amenities and facilities
 - Utilization of space for overflow, tournament and temporary uses
