#### B. COUNCIL ACTION/DISCUSSION

## 20-4502 Response and Actions Related to COVID-19

Discussion took place regarding beach openings and restaurant outdoor dining.

Mr. Lavallee spoke to restaurants complying with outdoor dining social distancing standards, Coalition of Business Associations (COBA) letter received dated May 1, 2020 to include requests to expedite applications and waive permit fees, and responded to council questions regarding city's cost to waive fees, budget being affected, and the building department's enterprise fund balance.

Ms. Senne noted the ending fund balance for the building department's enterprise fund.

#### 20-4503

Request Sending a Letter to the Governor Regarding COVID-19 Testing (Feinsod)

Mayor Feinsod spoke to his request for a COVID-19 test site in Venice.

Discussion followed on test sites in Sarasota County, the city's age demographic, testing first responders first, communicating request to the county, testing in pharmacies, and April 24, 2020 Executive Order No. 20-006 issued by Governor DeSantis allowing licensed pharmacists in Florida to administer COVID-19 tests.

Deputy Chief Giddens spoke to testing sites and communicating with the Department of Health (DOH) for a potential testing site in Venice.

Discussion continued regarding involving the county, pharmacists administering tests, Deputy Chief Giddens communicating with the DOH, Executive Order No. 20-006, and availability of test kits.

There was consensus for Deputy Chief Giddens to contact the DOH for a potential COVID-19 testing site in Venice.

#### 20-4504

Discuss Assisting Businesses on West Venice Avenue (Feinsod)

Discussion followed regarding assisting downtown merchants, closing east side of West Venice Avenue to allow restaurants to expand outdoor dining, downtown survey conducted by staff, survey results, closing the street

during certain times, cost to close street(s), merchant support, resident feedback, parking concerns, equitability with other downtown businesses on Miami and Tampa Avenues, and concern with dining tables in the middle of the street.

Mr. Lavallee spoke to staff researching street closures, placing road barriers, cost to close one traffic lane, deliveries to merchants, emergency service access, parking, and allowing restaurants to expand outdoor dining areas along the sidewalk.

Discussion ensued on maintaining Americans with Disability Act (ADA) compliance, fee structure, obtaining feedback from neighboring merchants on expansion of outside dining areas, additional permitting costs, and charge for use of public space.

There was consensus for staff to research and obtain input on restaurants expanding outside dining areas along the downtown sidewalk.

Mr. Lavallee suggested scheduling a special meeting if results are favorable for council action.

Ms. Stelzer read written communication received from city resident Jackie Mineo.

Discussion continued regarding downtown sidewalk width, social distancing between diners and pedestrians, and personal responsibility.

Ms. Fernandez commented on the email included in the agenda packet between Mayor Feinsod and Vice Mayor Newsom on this topic.

Discussion took place on the mayor's response to emails addressed to council.

Recess was taken at 10:34 a.m. until 10:43 a.m.

## C. PRESENTATION

20-4505 Finance Director Linda Senne: FY20 Budget Update (10 min.)

Ms. Senne spoke on general fund expenses to include COVID-19 related expenses and measures taken to conserve cash.

Mr. Pachota returned to the meeting at 10:45 a.m.

Ms. Senne spoke on personnel costs, operating expenses, capital outlay, projected FY20 revenues, budget variance, proposed budget to city council in June, balanced budget, projected one-cent sales tax revenues, utilities

fund, state revenues, and responded to council questions regarding projected one-cent sales tax revenues.

Discussion followed regarding capital spending in the general fund, creating a flexible budget, and formulating a contingency plan for revenue degradation.

Mr. Lavallee spoke to the cancellation of the July 4, 2020 fireworks and requested council's input.

Discussion followed on delaying fireworks to a later date, cost of fireworks, and conserving money.

Ms. Stelzer read written communication received from city resident Mike Rafferty.
