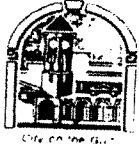

Mayor Holic announced this is a quasi-judicial procedure and opened the public hearing.

Ms. Fernandez questioned council members on conflicts of interest and ex-parte communications. Mr. Newsom disclosed attending the planning commission meeting and site visit, Ms. Fiedler disclosed site visit and communication with a resident regarding flooding in his ditch, and Ms. Moore and Mayor Holic disclosed site visits.

No written communication was received.

Mr. Shrum, being duly sworn, explained the term "variance" as presented in the preliminary plat application, and commented on code modifications, new development standards, and land development regulations (LDR) update.

Mr. Clark, being duly sworn, provided a presentation and spoke on subject property to include plotted alleyway, project proposal, proposed lot coverage, code modifications, comprehensive plan, vested rights approval by city council, LDRs, conclusions and findings of fact, planning commission's action, and responded to council questions regarding parking space widths, conditions listed in Development Order 18-04PP, using the alleyway as a swale, Venice Avenue sidewalk expansion, parking, stormwater runoff improvements, variance terminology in the LDRs, and Office, Professional, and Institutional (OPI) uses.

Jeffery Boone, representing the applicant, being duly sworn, spoke regarding Venice Avenue access point, preserving alleyway buffer, stormwater swale, townhouse renderings, parking, open space, modifications versus variances, preliminary plat approach, planning commission's approval, parking space widths, and the neighborhoods preference to have residential development.

Discussion followed on housing square footage, affordable housing, stormwater swale drainage plan, neighborhood concerns, fence, landscaping plan, residential garbage cans, street parking on Venice Avenue, and parking spaces.

Mayor Holic closed the public hearing.

Mayor Holic announced this is a quasi-judicial procedure.

Ms. Stelzer read the ordinance by title only.

Mayor Holic opened the public hearing.

Ms. Fernandez questioned council members on conflicts of interest and ex-parte communications. Mr. Newsom disclosed attending the planning commission meeting and site visit, and Ms. Moore, Ms. Fiedler, and Mayor Holic disclosed site visits.

Ms. Stelzer noted written communication was included in the agenda packet.

Mr. Shrum, being duly sworn, noted property is not in the joint planning area (JPA) with Sarasota County and commented on the property's history, Bert Harris Act, project density, the county's involvement, reviewing site and development plan, traffic study, and county permitting for right-of-way and access points.

Mr. Clark, being duly sworn, provided a presentation and spoke to property background, aerial and site photographs, surrounding property information, future land use map (FLUM), zoning map, planning analysis, requested code modifications, approved and proposed planned unit development (PUD) layout, consistency with the comprehensive plan and land development code (LDC), criteria for rezoning amendments, concurrency/transportation mobility, findings of fact, and responded to council questions regarding stipulations from the planning commission and perimeter setbacks.

Discussion followed regarding Pinebrook Road level of service (LOS), mobility credits, and Hatchett Creek Boulevard to include lighting.


