24-0048 Discuss Extending the Ranking Period and Process (Mayor Pachota)

City of Venice Page 1 of 2 Mayor Pachota introduced the topic of extending the ranking period and process for the Citizen Advisory Board applications.

Mrs. Frank advised the school and principal would welcome additional time to provide more student applicants if Council allows.

Mayor Pachota requested more time to evaluate applicants, more time for the schools, and refining the list to 15 applicants for ranking.

Discussion took place regarding the evaluation process, the time constraints, narrowing to 15 applicants, and possibly using the current results to reduce the list to 15.

City Manager Lavallee commented on the process in the past.

Discussion continued regarding ranking submissions, extending no more than one week, interviews by choice, and getting the appointments on the agenda for the last meeting in February.

A motion was made by Mayor Pachota, seconded by Vice Mayor Boldt, to extend Council's ranking deadline for the Citizen Advisory Board applications to Friday, February 9, 2024, with the City Clerk providing a list of the top 15 applicants at the next meeting for Council to provide direction in the next step for final ranking at the February 28th, 2024 meeting, with the student application deadline being extended for two weeks (to be filled later).
