C. PRESENTATIONS

Dave Wimberly, President, and Paul Hollowell, Treasurer, Venice Aviation Society, Inc. (VASI): Support for an Air Traffic Control Tower at the Venice Airport (10 min.)

Dave Wimbelry, Venice Aviation Society, Inc., (VASI) provided a presentation on a recommended airport tower, increased air traffic, airport traffic patterns, and the mix of traffic types.

Paul Hollowell, VASI, gave a report on air traffic at the Venice Municipal Airport, including reasons for increased traffic, and areas impacted, and answered a Council question regarding the process of working with the Federal Aviation Administration (FAA),

City Manager Lavallee answered a question regarding the City's Airport Master Plan, and stated the need for it to be updated, the possibility of a preliminary study by a consultant as required by the FAA, and funding opportunities.

Mr. Wimberly answered Council questions regarding noise, the ability of an airport control tower to assist with noise issues, and three types of tower operations.

Michael Grossman, 167 Tampa Avenue East #715, spoke in favor of an airport tower.

A motion was made by Vice Mayor Pachota, seconded by Ms. Moore, to direct staff to engage the Federal Aviation Association (FAA) to move time frame up on an airport master plan and include pursuing any available grant funds in an effort to conserve City funds. The motion carried by the following vote:

Dick Longo, Central Venice Coalition: Venice Avenue/Pinebrook Road Intersection Traffic Mitigation Recommendations (15 min.)

Dick Longo and Steve Carr, representing the Central Venice Coalition, provided a presentation regarding a recommendation for traffic mitigation with a three-prong approach, the plans for Pinebrook Road and East Venice Avenue intersection as designed by Sarasota County, redesign of Pinebrook Road from Laurel Road to East Venice Avenue, (neighborhood entrances, speed limiting devices, monuments, new traffic signal, signal optimization, changes in speed limits, walking/bike riding sidewalks), and request for a formal neighborhood for Central Venice.

Discussion took place regarding complete streets, capital improvement schedule, road ownership, alternatives, integrating current roads, monument signs, and concerns regarding a traffic signal at Lucaya Avenue.

City Manager Lavallee answered a Council question about the next step to be taken.

Arlene Dooley, 1315 Pinebrook Court, expressed concerns about safety on Pinebrook Road.

A motion was made by Vice Mayor Pachota, seconded by Dr. Fiedler, to direct staff to compose a letter to Sarasota County reiterating the wish to be included in the traffic management update of the intersection project for Pinebrook Road, and authorize the Council Liaison to engage in communication regarding this topic. The motion carried unanimously by voice vote.

Recess was taken from 10:40 a.m. until 11:00 a.m.

Council Feedback and Discussion of Planning Commission's Recommended Land Development Regulations (LDRs)

Frank Wright, 521 Harbor Drive South, spoke in favor of historical preservation and expressed concerns that the current draft of the LDRs does not address this.

William Schaid,153 Palazzo Court, of the Venetian Golf and River Club Property Owners Association, expressed concerns about impacts of the proposed LDRs on commercial growth in residential areas.

Jeffrey Boone, 1001 Avenida Del Circo, expressed concern about the procedure for public comment and his representation 25 clients.

A motion was made by Dr. Neunder, seconded by Vice Mayor Pachota, to extend audience participation time limits to 20 minutes. The motion carried by the following vote:

Yes: 6 - Vice Mayor Pachota, Dr. Neunder, Dr. Fiedler, Mr. Boldt, Ms. Moore and Mrs. Frank

No: 1 - Mayor Feinsod

Mr. Boone spoke on concerns about the LDRs in relation to PUDs, commercial development, traffic, non-conforming properties, setback multipliers, compatibility issues, height of stories, and transitional areas architectural standards.

Pat Neal, 5860 Lakewood Ranch Boulevard, Sarasota and City of Venice property owner, spoke on the proposed LDRS, PUDs, against restrictions on commercial developments in PUDs, and acquiring vested rights.

Frank Wright, 521 Harbor Drive South, spoke further on historic districts, recommended protecting the Edgewood District, the John Nolen Plan, and a proposed ordinance by the Historic Preservation Board (HPB).

William Schaid had no further comments.

Planning and Zoning Director Clark commented on the previous presentation and the topics that were submitted from Council Members on

decision authority for conditional use and height exceptions, retails sales and service, compatibility, downtown building height, Certified Local Government (CLG) and merging of the Historic Preservation Board (HPB) and Architectural Review Board (ARB), building height in the Seaboard Improvement District, and architectural requirements in Laurel West and Knights Trail Transition Districts.

Discussion took place regarding height exceptions and analytical decisions versus political decisions.

A motion was made by Dr. Fiedler, seconded by Vice Mayor Pachota, for building height exception decision authority to remain with City Council. The motion carried by the following vote:

Yes: 7 - Mayor Feinsod, Vice Mayor Pachota, Dr. Neunder, Dr. Fiedler, Mr. Boldt, Ms. Moore and Mrs. Frank

Discussion took place regarding the retails sales and service size, community versus regional, compatibility, nonconforming uses, and Planned Unit Development (PUD) sizes.

There was consensus to change "X" to "P*" on retail sales and service, single user 40,000 feet or larger in Planned Unit Developments (PUDs) and increase to 65,000 square feet, in the Traditional District Use Table.

Recess was taken from 3:00 p.m. until 3:12 p.m.

Council Feedback and Discussion of Planning Commission's Recommended Land Development Regulations (LDRs)

Discussion took place regarding non-conforming retailers, 40,000 single-use and the Mixed Use Districts Use Table.

There was consensus to change the Knight's Trail Transitional area from "X" to "C" in the Mixed Use District Table for Single-users over 40,000.

There was consensus to continue the meeting until 5 p.m.

Discussion took place regarding compatibility, building setback mitigation, setback multipliers, comprehensive plan amendments, 35 feet height limits, flexibility for continuity downtown, history, 10 feet exceptions, appurtenances, and height calculations.

There was consensus to continue with current height limits of 35 feet, plus the option of asking for an exception of 10 feet in downtown, with 20% for appurtenances/ornaments and changing the term appurtenances to ornaments.

Discussion took place regarding CLG status and the possibility of having separate Architectural Review and Historic Preservation Boards, historic districts, the Edgewood District, the local register, 1929 and older homes, and an inventory of contributing structures.

Planning and Zoning Director Clark noted a recommendation from the

Planning Commission regarding building height in the Seaboard area.

Discussion continued regarding the Seaboard area, building heights, stories, setbacks, and infrastructure.

There was consensus to increase building height in the Seaboard district to 75 feet and have it consistent across the districts.

Discussion took place regarding Laurel West and Knights Trail transition districts, mixed use areas, and whether architectural standards should be implemented.

There was consensus for preferred architectural standards in the Laurel West and the Knights Trail transition areas, with the option of design alternatives.

Discussion took place regarding the recommendation of merging the ARB and HPB, CLG status, demolitions, and the local register.

Jill Pozarek,161 Portofino Drive, spoke on commercial development size in PUDs, and compatibility.

Ruth Cordner, 246 Montelluna Drive, spoke on the LDRs and the process for residents to be involved.

Tommye Whittaker, 613 West Venice Avenue, spoke on CLG and against combining the ARB and HPB.

Jeffery Boone, 1001 Avenida Del Circo, expressed concerns about the process for professionals representing clients during citizen input with potential new regulations.
