This acknowledges receipt of a certified request for letter of release to place the subject water distribution system into service [DEP Form 62-555.900(9)] and supportive documentation on August 29, 2017. This project was approved for construction under the county permit tracking system number described above, issued on August 22, 2016.

Your engineer of record has certified that the subject facilities have been completed to the full extend of the approved plans and specifications. These facilities were cleared bacteriologically in accordance with Rule 62-555.345 Florida Administrative Code with submission of satisfactory bacteriological samples which were collected on June 8th, 9th, 13th and June 14th of 2017.

Based on this information, we are issuing this letter of release to place into service the water for the subject facility.

Changes in applicable laws and regulations with affect operating procedures and/or quality standards must be complied with. In addition, we wish to call your attention to the requirements that no sanitary hazards, regardless of how slight, shall be placed within 100 feet of public water supply well and under certain circumstances, this distance can be increased.
