	Jackson Boone, Agent for the applicant, presented the text amendment, the reason for the 10% vs. 15%, inventory, zoning districts, flex use, other jurisdictions' utilization of flex use, consistency with the Comprehensive Plan, the Land Development Code, requested approval, and answered a Council question whether there is another process to address this issue rather than a text amendment.
