This is in response to your inquiry this morning.

As you note, our prior requests for Affected Person Status, as granted by the Planning Commission, were filed also for the City Council hearing.

Our current requests are attached.

Our request (as substitute counsel) for Venetian Golf & River Club Property Owners Association, Inc. (VG&RCPOA) remains as submitted, except to note here that the presentation, as a called witness, by professional planner Jan Norsoph will be for VG&RCPOA as well as North Venice Neighborhood Alliance, Inc. (NVNA), for which he testified at the Planning Commission hearing.

Our request for North Venice Neighborhood Alliance, Inc. (NVNA) also stands as submitted, for the City Council hearing, except to revise it in the attachment hereto to substitute a new second page. The revision deletes the reference to Gary Scott as a Director of NVNA, as that is a position which he no longer holds. We understand that Mr. Scott will be separately requesting Affected Person status, in part to present as to issues within his direct personal knowledge.

Also, our prior request for Affected Person Status was jointly for NVNA and for Suzanne Metzger individually. The revised attachment deletes her from that prior request. Instead, she is now joined with two other Cielo homeowners, Tim Kenny and Seth Thompson, in the new, separate request for Affected Person Status attached hereto.

As such, we now have three requests for Affected Person Status, for:

Venetian Golf & River Club Property Owners Association, Inc. (as previously filed)
North Venice Neighborhood Alliance, Inc. (revised herein)
Identified Cielo Homeowners: Tim Kenny, Suzanne Metzger and Seth Thompson (newly filed, attached)

Our presentation for the Cielo Homeowners will focus on issues particular to Cielo. Our presentations for VG&RCPOA and NVNA will address other issues of concern to each of them, without redundancy.
