

**AMENDMENT NO. 2  
TO AGREEMENT NO. CAC2017-0155**

This Amendment is made and entered into upon execution by both parties by and between **Sarasota County**, a political subdivision of the State of Florida, hereinafter referred to as the "**County**," and **City of Venice**, hereinafter referred to as "**City**."

**WITNESSETH**

**WHEREAS**, the County and the City entered into Agreement No. CAC2017-0155 ("Agreement") for the provision of hosting and related technology services, effective September 13, 2017; and

**WHEREAS**, on September 6, 2018, the County and the City executed Amendment No. 1, renewing the term of the Agreement, revising the Agreement, and revising Exhibit A – Pricing for Delivered Services; and

**WHEREAS**, the parties now wish to further amend the Agreement.

**NOW THEREFORE**, the County and the City, in consideration of the mutual covenants contained herein, do agree to amend the Agreement as follows:

1. The above recitals are true and correct and incorporated herein by reference.
2. The term of the Agreement is hereby renewed for a period of one (1) year, effective September 13, 2019 through September 12, 2020.
3. For services provided pursuant to this Amendment, the City shall pay the County for the services rendered hereunder and completed in accordance with the terms and conditions of this Contract an amount not to exceed \$3,330.48 for the renewal term. Initial payment of \$277.54 is due by October 1, 2019. The remainder is due and payable in monthly installments of \$277.54 each and shall be paid on the first of every month.
4. The Pricing for Delivered Services as of the effective date of the Amendment is attached hereto and incorporated herein as Exhibit A – Pricing for Delivered Services.
5. Except as modified herein, all other terms, covenants, and conditions of the Agreement shall remain in full force and effect.
