My name is Megan J. Ellis and I am a licensed attorney, Florida Bar #00664901, authorized to practice law in Florida and am currently practicing law in the State of Florida. Pursuant to the requirements of Florida Statutes, Chapter 177, and Sarasota County Land Development regulations, I have examined record title information to the real property described in the attached **Exhibit A**, which is incorporated herein by reference, said land being located in Sarasota County, Florida (the "**Property**").evidenced by that certain Plat Property Information Report, a copy of which is attached hereto as **Exhibit B** (the "**Title Report**").

Based solely upon my examination of the Title Report, and assuming the accuracy of the information contained therein, the record owner of the Property is Toll Southeast LP Company, Inc., a Delaware corporation (hereinafter "Owner"). The Owner acquired record title to the subject real property by the following instrument recorded at Instrument No. 2019172763, of the Public Records, Sarasota County, Florida.

Subject to the qualifications and assumptions contained herein, based upon the Title Report, (i) the Owner has a fee simple title to the Property, however, subject to the encumbrances or qualifications set forth on **Exhibit B** attached hereto, (ii) there are no mortgages encumbering the Property, nor is the Property subject to any financing statements, and (iii) all 2020 property taxes have been paid on the Property as of the date of the certification.
