#### I. FINANCE DIRECTOR LINDA SENNE: UPDATE ON FY2024 BUDGET CHANGES

23-6233 FY2024 Budget Changes Since the September 12, 2023 Budget Public Hearing

Finance Director Senne noted the reduction in the millage rate from 4.3600 mills to 3.9041 mills resulting in decreased budgeted revenues by \$2,864,000.
