**COUNCIL ACTION REQUESTED**: Presentation with Action Requested

On April 4<sup>th</sup> of this year, a workshop was held with City Council to discuss the topic of "unified control" as it relates to proposed amendments to PUDs. During the workshop, planning staff provided results of research of other community's processes to amend PUDs. City Council provided the following direction as a result of the workshop:

There was consensus to direct staff to hire an attorney to 1. Provide an opinion on whether the City would be in violation of the state moratorium on development restrictions, and 2. Draft language based on Modified Option 2, with options and definitions on specific details, and to do so as expeditiously as possible.

The City Attorney issued requests for legal services to multiple attorneys. As a result, Alison Yurko, PA was contracted to provide counsel on the indicated issue. The City Attorney and Planning and Zoning Director have met with Ms. Yurko on multiple occasions to discuss and provide direction on the issue. The attached memo from Ms. Yurko provides the results of her research and makes recommendations as to how the City can address the issue through amendments to its Land Development Regulations.

<u>Council Action Requested</u>: Move to have the necessary amendments to the City's land development regulations drafted to implement special counsel's recommendations for the processing and consideration of PUD amendments.
