Here is the complete set of plans for the site improvements and Gene Green road straightening we talked about on the phone. Sheet C1.02 shows the proposed road location.

As discussed with Colton last year, we will be building the new road to completion before doing anything to the old road. Your trucks will not be impacted at all during construction. We will complete the new portion of the road, have the new access easement recorded, shift traffic to the new road location, then demo the old road. This will be a new road for you all to use and will be safer as we won't have people walking back in forth across the road anymore going back and forth between our different buildings.

Our meeting with the City is Tuesday next week and the City wants to make sure you all are know what we are proposing and that your traffic will not be impacted.
