Samantha,

I will ask council to direct staff to research the goat and see if it can be used effectively on any of our outfalls, this will be done at the next council meeting. In the meantime, I would like to propose the following to you:

As background, when my wife and I were Turtle Patrol volunteers, we would carry a couple of bags with us and pick up trash. In the mile of beach that we walked, rarely would there be a morning that we did not fill up two bags with bottles, plastic bags, cans and other discarded "garbage". I would suggest to you that litter from beach combers far exceeds that from the outfalls.

You are part of an organization that is already familiar with the area and has likeminded people concerned about what is going into our waterway. I suggest you ask the Hands Along the Water folks to begin a program similar to Adopt - a - Road, and it can be as simple as Adopt - a - Beach. If the beach is divided into half mile sections from the Jetty to as far south as you want to go and another group can be started from the north jetty to as far north as you want to go for beach debris pickup. I will go to council and ask for support for whatever you need to get the job done and will be happy to recommend the approval of signs giving the organization recognition for adopting the beach if you would like.

I think this is as important, if not more so, than the goat as both are designed to remove debris, not excess nutrients. Council has already directed staff to get a beach rake so that the next time we have a fish kill, the dead fish are picked up on a timely manner as they actually provide excess nutrients to the algae. The rake will also help remove some of the cigarette butts along the water's edge, it will not help with the debris further up the beach and in the grassy areas.

Our monitoring of the quality of the outfall water should help us determine where the excess nutrients are coming from in the city and then develop a plan to stop it. Water quality monitoring, however, will not address the debris so I think this type of volunteer action can work hand in hand for better overall water quality.

Kim,

I attended a Council of Governments meeting in Sarasota yesterday and was able to talk with a City of Sarasota Commissioner and the Assistant City Manager and I asked about the "water goat". Neither person was familiar with that term or piece of equipment. The City of Sarasota uses baffles to capture debris and the City of Venice uses several techniques, including baffles, to capture debris; I will forward you a separate email on all the outfalls of Venice.

The Watergoat is a Tampa innovation and I will ask our City Manager to have our Storm Water Engineer look into it to see if it can improve our debris collection; fortunately we do not have the volume of debris that Tampa has. As you know, unlike a naturally occurring phenomena like red tide, debris is almost totally man made and could be easily corrected if people weren't so careless and disrespectful of the environment. Cans, plastic bags, plastic bottles and cigarette butts shouldn't take tax dollars to fix and shouldn't be the responsibility of government. We can't correct a problem by trying to clean up the results, the problem is corrected by not contributing debris at the source and that is everyone's responsibility. Nature's contribution, like leaves, pretty well take care of themselves.

Kim,

That is part of the assessment. When we have everything in place we should get a very good idea what we are adding to the storm water, if anything.

For example, I had a complaint about the drain leading into the basin by Freedom Boats Club and it turned out to be three pollen on the water along with some dead leaves. There was a piece of bread floating in the water and that was most probably from a visitor trying to feed fish. A couple of years ago, when we had a beach closing, we found that there was a resident throwing a large amount of bread into the water almost every morning to feed the birds and it may have been the bird deification that was causing the closing. Sometime the thoughtful actions of people can actually be harmful to the ecosystem; we were able to find the resident and stop that feeding.

I guess what I'm trying to say is it is best to leave it to the professionals so that we don't yell fire when there may not be one and that we find the actual fire and put it out.
